Pabitra Thapa, was shopping at Salbari Hat, at that movement one unknown man approached her and took her to the side lane near Soltee furniture asking for money exchanging place. The man claimed to be a resident of Teesta and was going towards Nepal. Further one another unknown man also joined and asked her if there was a bank nearby, but my mother directly refused having any idea about Bank and money exchanging office nearby. They further offered her a package wrapped in handkerchief calming to have money inside in exchange of her two golden rings, one ring approx. half tola with the initial "P" on it and the other was approx 4 ana with a black stone on it which she refused to accept and tried to escape but she was already scared till then. Thereafter they manipulated my mother to handover the golden rings and forcefully handed over the package wrapped in handkerchief which later we discovered as bundle of folded newspaper.
