Sub - FIR

Sir,

In producing herewith 01 accused person namely Sudhir Kumar (32 yrs) S/O Satrugan Roy of Vill- Berai, PO- Berai, P.S- Hathoiri, Dist.- Mujaffarpur, Bihar under arrest along with the following seized articles under proper seizure viz :- (i) one blue colour Trolley bag containing 20 (twenty) bottles of Royal Star Golden Brandy each bottle containing 750 ml i.e, total (20 x 750 ml) = 15 ltrs - Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and Marked as Exhibit "A1". I SI Goutam Mallik of Pradhannagar P.S, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person namely Sudhir Kumar (32 yrs) S/O Satrugan Roy of Vill- Berai, PO- Berai, PS- Hathoiri, Dist.- Mujaffarpur, Bihar to the effect that on 20.02.2025 at 21.15 hrs myself along with SI Rajiv Subba, SI Bandhan Roy along with force left the PS to perform evening PC Mobile van duty vide Pradhan Nagar PS GDE No 1159 dated 20.02.25. During my duty at around 22.30 hrs I received secret source information that one person is standing at in front of Jay Matadi Bus counter, Siliguri Junction under PS- Pradhan Nagar, Dist. Darjeeling with huge quantity of illicit liquor and waiting there for a Bihar bound Bus. Accordingly I informed the fact to you and you directed me to work out the information in hand. As per your kind order and direction I also informed the fact to night RT Van Officer SI Amal Debnath of Pradhan Nagar PS and directed him to come to near Jay Matadi Bus Counter, Siliguri Junction. At around 22.45 hrs I along with force arrived at near Jay Matadi Bus Counter, Siliguri Junction and after a while night RT Van officer SI Amal Debnath arrive there and accompanied with us. At around 22.55 hrs being pointed by the source I noticed one person with a blue colour Trolley bag in his possession is standing in front of Jay Matadi Bus Counter, Siliguri Junction. We cordoned the place carefully and managed to detain him. On interrogation he disclosed his identity as noted above. On further interrogation he disclosed that he is carrying illegal liquor in his bag and waiting there for a Bihar bound bus. On search the bag in his possession the above noted liquor was recovered from the bag which he kept conceal inside the bag. On demand he failed to produce any valid documents or licence to possess/carry such illicit liquor. As he willfully violated the norms of Bengal Excise Act hence, I seized the above noted illegal liquor from his possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 23.05 hrs to 23.35 hrs under the coverage of videography. Subsequently, I arrested the above noted detained person namely Sudhir Kumar (32 yrs) S/O Satrugan Roy of Vill- Berai, PO- Berai, PS- Hathoiri, Dist.- Mujaffarpur, Bihar after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused person namely Sudhir Kumar (32 yrs) S/O Satrugan Roy of Vill- Berai, PO- Berai, PS- Hathoiri, Dist.- Mujaffarpur, Bihar for violating the provisions of W.B. Excise Act.
