Sir,

I, SI Kazi Rejaul Karim of New Jalpaiguri Police Station, SPC do hereby lodge this complaint, to the effect that on 18.02.25 at 17.05hrs in course of evening mobile van duty, I received a source information that some vehicle loaded with sand illegally are coming from Balasun River side and proceeding towards NJP side, accordingly I informed the matter to you and also duty officer of PS and proceeding to Kashmir Colony side to verify the veracity of the information. At 17.25 hrs hrs we arrived at Kashmir Colony more and intercept 04 (four) number of Dumper Truck coming towards Tinbatti side loaded with sand and seeing police presence the drivers of the said Dumper Trucks fled away left behind the vehicles on roadside at Kashmir Colony more under NJP PS, Jalpaiguri. We try to intercept the drivers but in vain. The registration numbers of the vehicles are WB-33E/7832,WB-73H/1642, WB-73G/6072 and WB73-H/7786. I search nearby, but no one came forward as driver or owner of the vehicles. Thus it is reason to believe that the owners and drivers of the above noted vehicles are procured the sand by illegal means or by stolen from the river bed and loaded in the vehicles for selling the same to earn huge money and thereby causing huge revenue loss to the Govt. of W.B.

Finding no alternative, I seized the vehicles having registration no. WB-33E/7832,WB-73H/1642, WB-73G/6072 and WB73-H/7786 loaded with sand under proper seizure list in presence of witnesses and taken in custody. The entire process were done under proper videography. The seizure process has been made in-between 18.05 hrs to 18.25hrs.

Hence, I pray that a specific case may kindly be started against the register owner and the driver of the seized vehicles under proper section of Law and arrange for its investigation.
