In producing herewith the following five accused persons namely 1) Mintu Mandal(38) s/o Lt Binoy Mandal of Bharat Nagar PS Siliguri Dist Darjeeling 2) Sribash Mallick (33) s/o Nibar Mallick of Roy Para Sahid Colony PS NJP Dist Jalpaiguri 3) Sambhu Mandal (40) s/o Sideshwar Mandal of Thakur Nagar PS NJP Dist Jalpiguri 4) Gobinda Biswas (36) s/o Nitai Biswas of Sahid Colony Bhaktinagar PS NJP Dist Jalpaiguri 5) Pawan @ Bapanta Adhikary (34) s/o Lalbabu Adhikary of Baribhasa Langra more PS NJP Dist Jalpaiguri along with the seized articles viz. (i) Rs 45000/- (Fourty five thousand of ICNs) from the procession of Pawan Adhikary ii) Rs 2000/- (Two thousand of ICNs) from the possession of Sambhu Mandal iii) Rs 5000/- (Five Thousand Of ICNs) from the procession of Mintu Mandal iv) Rs 24000/- (Thwety Four Thousand of ICNs) from the possession of Shibash Mallick v) Rs 1770/- (One thousand seven hundred seventy of ICNs) from Gabinda Biswas (Total Rs 77770/-(Seventy Seven thousand seventy of ICNs) as board money.

- (vi) 52(fifty two) numbers of used playing cards.
- (vii) Two brand new bundle of playing card stayed as "DECK"
- (viii) One 40 W LED blab.
- (ix) One blanket black and green colour, under proper seizure list,

I, SI Tanmay Kundu do hereby lodge this complaint to the effect that on 18/02/15 at 20:05 hrs I received a source information that a gambling with cards is going on at Jorapani which is arranged by Sujit Mallick in his shop situated at Sahid Colony. The information was diarized vide NJP PS GDE No. 962/25 dt 16/02/25. Being directed by the I.C of PS, I along with ASI Manoj Majumdar C/ 1462 Sajan Tamang, VP 13 Jamirul Islam VP 08 Laxman Roy left PS to work out the information on 20: 15 hrs which was diarized in NJP PS GDE NO 964 dated 18-02-2025. At 20:40 hrs we reached at jorapani in front of the shop of Sujit Mallick, being identified by the source and cordoned the shop with a strong reason to believe that an illegal gambling is going on inside the shop.

Accordingly, prior to the entering inside the house we called two available disinterested local witnesses namely (i) Gobinda Sarkar (32) s/o Santosh Sarkar of Dabgram PS Siliguri Dist Darjeeling (ii) Pintu Das (24) s/o Lt Hari Das of NJP IOC gate Sahid colony PS NJP Dist Jalpaiguri and on request, they accompanied us during the whole search and raid session. On entering inside the shop of said Sujit Mallick with the above mentioned witnesses, found the above noted accused persons were gambling with the playing cards and money with a view to wrongful gain to one and wrongful loss to another inside the said shop under electric light and using the shop as common gaming house.

I accordingly seized the cash as board money and other articles as noted earlier from the joint possession of the five arrested accused persons noted above under proper seizure list in presence of witnesses and proper videography and dully signed by them. And the five accused persons as mentioned above were arrested as they violated the rules laid down under section 3/4 of West Bengal Gambling and Prize Competition Act XXX of 1957 and they were taken into custody and memo of arrest were supplied to them apprising their ground of arrest. The whole time of seizure is made in between 21:15 hrs to 21:55 hrs.

I, therefore, pray that a specific case may kindly be started against the above mentioned five accused persons and the owner of the said shop named Sujit Mallick of Baribhasa under PS NJP Dist Jalpaiguri under section 3/4 West Bengal Gambling and Prize Competition Act XXX of 1957.
