Gauri Shankar Das & his wife namely B) Sona Das, both are of Nainipara, came to our home at Ganga Nagar Road No.2, and told my mother namely, Smt. Meena Devi Das (70) S/o Lt. Gauri Shankar Das, to remove the building materials from his portion of land nearby our home and when my said mother & we protested them they started abusing us in filthy language and then said wife caught me by hair and my said elder brother hit on my head with brick and injured me grievously and my said mother also received severe injury. I immediately shifted to Siliguri Distt. Hospital with my said mother namely, Smt. Meena Devi Das (70) and treated ourselves here.

So, Please take necessary action against my above noted elder brother-in-law & sister-in-law, noted above, because they have also threatened us for some consequences, if we will stop to sell his share of land nearby our home at Ganga Nagar Road No.2.
