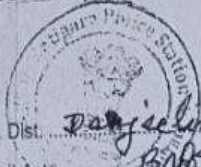

Sir,

In producing herewith one arrested accused namely Bikash Kumar Sah (32 yrs), S/O- Raj Kumar Sah of Rabindranagar near Matri Chaya, PS- Matigara, Dist- Darjeeling along with seized vehicle bearing Reg. No. WB 73 E 9985 loaded with riverbed materials, I ASI Bikash Roy of Matigara P.S. SPC do hereby lodge a Complaint against the above noted accused person to the effect that on 27.02.2025 at 09:10 hrs, received an information from reliable source that one Bolero Pick Up loaded with illegally mining riverbed materials is coming from Balason Ghat towards Matigara Govt. Colony. On receiving the information I along with available force rushed to the spot to work out the information. Under information and kind order of I/C Matigara P.S on arrival at Govt. Colony, under Matigara P.S area, I found said Bolero Pick Up bearing Reg. No. WB 73 E 9985 loaded with riverbed materials is coming towards Govt. Colony. Subsequently, I managed to stop the vehicle at Govt. Colony and asked the driver to produce valid documents / papers of the said riverbed materials, but he failed to produce any valid documents in support of said materials. As such I also seized the above noted loaded Bolero Pick Up bearing Reg. No. WB 73 E 9985 under proper seizure list and arrested the driver namely Bikash Kumar Sah (32 yrs), S/O- Raj Kumar Sah of Rabindranagar near Matri Chaya, PS- Matigara, Dist- Darjeeling under proper memo of arrest and brought to the above noted vehicle at P.S. The whole process of seizure and arrest was made on 27.02.2025 in between 09:25 hrs to 09:40 hrs. The whole process of seizure was made under videography.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the vehicle namely Bikash Kumar Sah (32 yrs), S/O- Raj Kumar Sah of Rabindranagar near Matri Chaya, PS- Matigara, Dist- Darjeeling and the seized Bolero Pick Up bearing Reg. No. WB 73 E 9985 under proper section of law and arrange for its investigation.
