Subject: Physical Assault and attempt to Murder

Respected Sir,

I Ashmeet Singh, Son of Late Jasbir Singh, residing at Hotel Saluja, Ward No. 06, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling West Bengal - 734001, wish to file this First Information Report regarding a grievous incident that occurred on 02.03.2025 around 6:45 PM near Ashisbaal Nursing Home, Mangal Pandey Road, Khatpore Siliguri Ward No. 9 P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling - 734005.

While driving through the aforementioned location, a Taxi Driver operating a Toyota Innova Coysta, bearing registration number WB73F0515, acted in a highly aggressive and dangerous manner. The driver, who appeared to be heavily intoxicated, used abusive and obscene language shouting, "Mudrochod Teri maa chood danga, gadi piche tar!" He abruptly stopped his vehicle, exited and confronted me violently

He physically assaulted me with fists and blows, attempted to remove my pageli (turban) and hurled threats to kill me. In his drunken state, he struck my head with his car key causing severe injuries, with my bone was looking through the cut I was repeatedly slapped beaten and fully ~~so~~ soaked in blood and left in left in a helpless state. My condition deteriorated to the extent that I fell to the ground & could not get up on my own.

Following the assault, I sought immediate medical attention at Siliguri District Hospital where I received treatment including stitches on my head. The nature of the attack, the severity of my injuries and the aggressive threats made by the accused clearly indicate an attempt to murder.

I therefore request YOU TO, register this complaint as an FIR against the accused driver

I am willing to cooperate fully with the investigation.
