case under proper section of law.

I Ajay Kumar Gupta (58) S/o Lt. Sahyadeb Prasad, the  
above noted complainant beg to inform you that I am an  
advocate, by profession and my chamber is attached with  
my house, and I reside at Rani Sati Mandir Road, Ganga Nagar  
Ward No. 5 SMC, P.S. Solegaon, along with my 02 (two) sons namely  
Yash Gupta & Suryanshu Gupta and my wife namely, Smt.  
Arunima Rani Gupta. My relationship with my said family  
is quite awful as none of them likes me and their  
behaviour towards me is very negligible and disrespectful.  
Being a father and a husband, I did every possible things  
for them for their livelihood and education.

Generally everyday my said wife & two sons abuse me in  
filthy languages & they do not offer me proper food, always  
try to insult my clients, who comes to my chamber to take  
legal consultancy from me, my said family & members use  
to take money from my chamber & losses without informing me  
& often they hit me with whatever they can get in their  
hands, always try to create disturbances to harm my mental  
peace; & these are their daily habits, & they threaten me also.

On 28.02.2025 at about 09:30 pm, when I was working  
at my chamber at Ganga Nagar (Rani Sati Mandir Road)  
at that time my said wife and two sons entered into my chamber  
and started abusing me in filthy languages and tried to  
provoke me, and then after my said wife bolted the door  
of my chamber, and my younger son Suryanshu Gupta, picked  
up a wooden Botam (wooden log) and attacked on me and  
my another son Yash Gupta, started taking the videos of  
said incident with mobile phone and this way my said  
wife restrained me and my said elder son Suryanshu Gupta  
injured me grievously and broken my left arm with intention  
to make me permanently, so I could not work for ever and  
my younger son, Yash Gupta, took the videos to defame me.

Sir, my said wife have filed a criminal case against  
me U/S 498 A IPC, in 2013, blaming me that I tried to  
burn her live, which is still pending before the Tel. Court  
at Solegaon.

I anyhow immediately went to Solegaon Distt. Hospital  
and seeing my serious condition, the concerned doctors admitted  
me there on 28.02.2025 and discharged on 01.03.2025,  
and doctors have clearly indicated that my arm's bone has been  
fractured (Undisplaced linear # of shaft V/ra (Lt.)), which is  
enclosed herewith. So please take necessary action against my wife & 2 sons.
