Sir,

In producing herewith three (03) accused persons namely 1. Mahabub Khan (20) s/o Raju Khan of Fulbari Nipania POFulbari PSNJP Dist Jalpaiguri 2) Sayan Malakar (20) s/o Shapan Malakar of Balaka More PO Shaktigarh PS NJP Dist Jalpaiguri 3) Basanto Kr Rai (28) s/o Mitra Kr Rai of Kashmir Colony PO Bhaktinagar PS NJP Dist Jalpaiguri along with seized articles viz:-

1. One Ram Dao length measuring approx 3 feet with wooden butt.
2. One iron road ,length measuring approx 3 feet.
3. One iron made "kural( axe)" with wooden handle.
4. One Nylon rope ,blue in colour
5. One Electronic torch lights from the PO.

I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 8/9 persons to the effect that on the night 26.02-25 at 01-25 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Kashmir Colony ground under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 1321 dt. 26.02.25 . As per your kind direction at 01-35 hrs myself along with, C/1462 Sajan Tamang, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS vide NJP PS GDE No. 1322 dt. 26.02.25 for Kashmir Colony ground to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 01-55 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the ground of Kashmir colony, found a group of 10/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted three (03) persons and the others 08/09 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Kashmir colony under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not find any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graphy as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS. The seizure was made between 02-45 hrs to 03-15 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1. Mahabub Khan (20) s/o Raju Khan of Fulbari Nipania POFulbari PSNJP Dist Jalpaiguri 2) Sayan Malakar (20) s/o Shapan Malakar of Balaka More PO Shaktigarh PS NJP Dist Jalpaiguri 3) Basanto Kr Rai (28) s/o Mitra Kr Rai of Kashmir Colony PO Bhaktinagar PS NJP Dist Jalpaiguri and other 8/9 persons and arranged for its investigation.
