I, Md Ruhul Amin, Son of Md. Jahiruddin, resident of R.K hostel, P.O. N.B.U, P.s. Matigara, Dt. Darjeeling would like to inform you that I am the student of Botany department presently I am studying in 4th semester. My practical class was held today and as per my schedule like every day at about 1.45 PM (noon) I have appeared before my department to attend my class that time I have seen some outsider hooligan supporter leaded by Sri Tanmoy Adhikary, Son of unknown, resident of Leninpur under the name of style of SFI creating blocked to the student from attending in to their respective class. When they tried to blocked from entering me in to my department I have raised vehement objection. After listening my protest they had became very violent and aforesaid Tanmoy Adhikary started to threatening me by saying the word in Bengali "Tui campuser baire ai toke dekha nibo. Instantly I refused to leave the place that time they have started beaten me mercilessly by fist blows and kicked at my back. As a result I had fallen on the nearby road and sustain severe injury on my person.
