Suddenly someone was knocking my door. When
I open the door, I was shocked to see that
my neighbour namely Rana Das, Resident of
Samar Nagar Battala, P.O. Champasari, P.S. Pradhan
Nagar, Dist. Darjeeling shouting at me in
drunken state. When I asked him what was
wrong? he suddenly began profanity and shove-
led at me and he used abusive language. When
I told him to leave in absence of my family
but he forcibly to enter into my room.
Suddenly he touched my hand and tried to
do something inappropriate with me. When I
tried to stop him, he grabbed me from
behind. I tried to resist, but he physi-
