 are resident of Gawalpatty Gully No 2 Ward no 4  
 S.M.C Shaukarmore P.S. Biliguri District Durgajeling  
 3. Md. Blanna Son of unknown and 4. Md. Aman Son of  
 Md. Blanna both are resident of coal Depot Shaukarmore  
 P.S. Biliguri District Durgajeling on 09/02/25 police of  
 Khalpara Tap came to investigate to the area but they  
 did not know the exact location of Sultan's house. At that  
 time police asked me about Sultan's house and I told them  
 about the housing Sultan. Later the incident on 10/02/25  
 mentioned above persons have followed me when I went for  
 marketing. Then I took funeral para road for going to my  
 house. Then the four persons hit me from behind side and  
 touch my body in inappropriate manner. After that they  
 kicked me on my private part and fist and blow on my face.  
 They physically assaulted me and trying to kill me  
 pulled my hair and tore my cloths.
