Respected Sir,

I, SI. Biplab Barman serving under your kind disposal filling this written complaint against 30/40 leaders and supporters of CPIM Darjeeling District Committee to the effect that on 03.03.2025 at 15.05 hrs during the Mobile patrolling van duty Vide MCC No. 463 Dt. 03.03.2025 I received an information that CPIM Darjeeling District Committee will bring out a protest rally, also information received that the said leaders and supporters may raise slogans which may provoke breach of peace in and out Siliguri PS area. Accordingly, I informed the matter to I/C Siliguri PS and ACP East - I, SPC over phone and I/C Siliguri diarized the matter for future reference vide Siliguri PS GDE No. 122 Dt. 03.03.2025 at 15.05 hrs. and directed SI. Biplab Sen, SI. Bipul Sarkar, SI. Gopal Chandra Mandal, C/1404. Ujjal Singha, C/1406. Biman Barman, C/1424. Ashok Barman, LC/1313. Milli Roy, LC/1210. Neelam Chhetri left PS for Airview More to avoid any adverse situation and to maintain law & order over the area.

At around 17.05 hrs I found a group of mob consisting approx 30/40 persons coming towards Airview More from Sevok More side by blocking the free flow of traffic, along with them they were carrying party flag of CPIM and they raising slogans. On arrival at Airview more, myself along with force under the direction of Shri. Robin Thapa, ACP, East - I, SPC tried to make them understand that as this is the pick hours of traffic movement and also Higher Secondary Candidates and other school students are returning from their institutions and it creating a great convenience on their way to home, also I urged them not to raised slogans and keep calm. Further they did not pay any heed towards the words of mine as well as the on-duty Police personnel including Shri. Robin Thapa, ACP, East - I, SPC. Accordingly they started demonstration in the middle of the Airview More by blocking the road. Wasting no time myself along with force went to stop them and they disobeyed the lawful direction of withdrawal the road blocking. Seeing the grievousness of the situation myself along with all officer and force immediately intervene and by convincing the leaders and finally make them understand to withdrawal their demonstration from the middle of the road. After that we managed to disperse the leaders and supporters of CPIM from Airview more and take control of the situation.

Therefore my humble request before you that a specific case may kindly be initiated against 30/40 unknown leaders and supporters of Darjeeling district, Communist Party of India (Marxist) for illegally and unlawfully assembled in the middle of the Airview More under the jurisdiction of Siliguri PS also for disobeying the direction of public servant.
