In producing herewith two arrested accused persons namely Sanjib Barman (27) S/O Nil Kamal Barman (Driver of tractor No. WB 74 BN 9966) and (2) Bankim Barman (29) S/O Tepu Barman (Driver of tractor No. WB 74 BQ 4061) both of Goyal Jote, PO- Nemaï, PS- Matigara, Dist- Darjeeling along with seized articles Viz (1) One blue coloured Tractor with trolley bearing No. WB 74 BN 9966 loaded with small stones and (2) One blue coloured Tractor with trolley bearing No. WB 74 BQ 4061 loaded with sand, I SI Biswajit Ghosh of DD SPC, Siliguri submitting complaint against both the driver of the seized vehicles and others to the effect that on 05.03.2025 at 22.15 hrs received a secret source information that some vehicles are illegally loading river bed materials from Balasan River under Matigara PS and are proceeding towards Matigara and surrounding areas through Khaprail road for Clandestine disposal for their wrongful gain. Accordingly, I diarised the information vide DD SPC, GDE No. 33 dated 05.03.2025 and inform the information to ACP, DD, SPC, Siliguri. As per order of ACP DD SPC, I along with SI Basudeb Guha Const.686 Arup Saha, all of DD SPC left DD office to verify the veracity of the source information. As per order of ACP DD SPC, called the night van officer SI Manoj Roy and team of Matigara PS for assistance .

At about 22.35 hrs we reached at Khaprail Road near Khaprail More in front Dr. P. D. Bhutia Clinic of under Matigara PS and as per the source information at about 22.40 hrs we found the above mentioned two tractors coming from Khaprail side and accordingly we stop the tractors . I disclosed our identity to the drivers of the vehicle and stated the ground for detaining the vehicles . We found that One blue coloured Tractor with trolley bearing No. WB 74 BN 9966 is loaded with small stones and other blue coloured Tractor with trolley bearing No. WB 74 BQ 4061 is loaded with sand. On question the drivers disclosed their name and address as Sanjib Barman (27) S/O Nil Kamal Barman (Driver of tractor No. WB 74 BN 9966) and (2) Bankim Barman (29) S/O Tepu Barman (Driver of tractor No. WB 74 BQ 4061) both of Goyal Jote, PO- Nemaï, PS- Matigara, Dist- Darjeeling. On demand he could not produce any documents in support of the possession/ carrying of such quantity of river bed materials and admitted that they along with others loaded the river bed materials from Balasan River by fraudulent means or by stolen means. Accordingly, I seized the (1) One blue coloured Tractor with trolley bearing No. WB 74 BN 9966 loaded with small stones and (2) One blue coloured Tractor with trolley bearing No. WB 74 BQ 4061 loaded with sand under proper seizure list in presence and duly signed by the witnesses under proper videography and arrested both the above mentioned person

O/S 35 of BNSS. The whole process of seizure was made in between 22.45 hrs and 23.35 hrs



I therefore, request you that a specific case may kindly be started against the drivers namely Sanjib Barman (27) S/O Nil Kamal Barman (Driver of tractor No. WB 74 BN 9966) and (2) Bankim Barman (29) S/O Tepu Barman (Driver of tractor No. WB 74 BQ 4061) both of Goyal Jote, PO- Nemaï, PS- Matigara, Dist- Darjeeling and others under proper section of law.
