Respected Sir,

I Seena Agarwal, Advocate by
profession, wife of Faraj Shaid, resident
of L.M. Moule Complex, Behind Hotel
Vinayak, Hill Cart Road, P.S. Siliguri,
Dist: Darjeeling beg to state as follows:

- ① That I had appointed one carpenter
namely Surya Kumar resident of Ashraf
Nagar, backside of Masjid Road, Near
Kali Mandir, being phone NO. 82505-16315
for making of furniture at my chamber
situated at L.M. Moule Complex, Behind
Hotel Vinayak, Hill Cart Road, P.S. Siliguri
Dist: Darjeeling.
- ② That the total deal for making of furniture
was finalized at a total of Rs 39,000/-
whereas on every weekend the part payment
was made to them according to their needs
and demands. Every time he demanded
the payment, he would induce me to
give him the payment and would
always threaten to stop the work and
not let anyone else do the work.

④ That on 8/2/25 when my work of the chamber is almost complete he came to my chamber where the work is going on and started to quarrel with me and started demanding an extra amount of Rs 20,000/- He further threatened to stop the work and destroy all the furniture if his demands were not met. When I objected he took demand, he started abusing me in filthy language. He forcefully came towards me with the intention to touch my body parts and disrobe me.

⑥ When I raised hue and cries he ran away but threatening to destroy my chamber's furniture. A lot of my raw materials from the site of work have been missing such as screw, electric wire, pencil etc.

⑤ That I have been trying to contact him since then but he is not responding.

As I kindly request you to take immediate strict action against him.
