One 8mtr. PCC Electric Pole has been broken at Najrul Sarani, East Vivekanandapally, near Radha Gobinda Mandir, back side of Swamiji Statute, Ward No. 39, by unknown vehicle at yesterday morning on 05th March, 2025. This has resulted in damage of property of WBSEDCL which includes a 8mtr. PCC Pole, ACSR Conductors, Iron material fittings etc.

As per information gathered from site, one vehicle **absconded** the site after damaging the electric pole.

The total damage incurred by WBSEDCL is Rs.13,270/-only (Thirteen Thousand two hundred and seventy only).
