3. That I am regularly paying the rent (khayat) of the stated land from the beginning along with other owners.
4. That some miscreants tried to occupy and to construct boundary wall on the said plot of land on 30th of Jan 25 and broke the demarcation wall. A tube well was also installed there without our knowledge.
5. That a G.D. was lodged in the Bhakhi Nagar police station against the same on 30th of January 25. The situation was intervened by Bhakhi Nagar PS, accordingly and construction work was suspended.
6. That in the meanwhile it is seen that they have encroached and constructed boundary wall over our land again.
7. That it is worth while to mention here that in previous occasion also on dated 17/08/23 some miscreants tried to construct illegal temporary structure at our piece of land and accordingly stopped by the intervention of the said Bhakhi Nagar police station. After few days of the said incident we received a consent letter from our parvar and others.

I therefore humbly request you to be kind enough to look into this matter and take the necessary steps so that ~~our~~ land may be protected from the illegal occupation by the miscreants and oblige thereby.
