I. Smt. Kalpana Mandal, W/o. Madheb Mandal, R/o. Ghugumali Main Road, W/o-37, P.O. Ghugumali, Dist - Jalpaiguri, would like to on 05/03/25 my son has parked his vehicle at "Niranjana Nagar Jubok Sangha Club and a person namely Debojit Saha S/o. Shyamal Saha, R/o of above mentioned address called my son over telephone and in response my son will bring his car back after sometime, thereafter the above noted person aggressively stated that he will break my son's car if he did not take out from the club as soon as possible and in response when my son stated that he will bring after some time then the above noted person started to abuse my son and started to threatened him with dire consequences and stated that he will break his car as soon as possible and when my son went to bring his car back at that moment ~~that~~ he started to threatened my son and also said that

he will kill my son. and on yesterday night
at about 11:30 p.m. when my son was at
home at that very moment my son went
to the said club and that very moment
above noted person namely Debojit Saha
with his group attacked my son, and
they jumped up onto my son mercilessly and
started to assault him with fist and blows
and the intention was to kill my son and
other dire consequences, and the above
noted person namely ① Debojit Saha, ②
Chottu ③ Bhutta, ④ Not known ⑤ Nabin
(Members of well known KGF group) and
other associates in the group all of them
started to assault my son with sharp
weapons along with Patti etc. and when
hearing the chaos my husband and I went
outside my house and found that my
son was lying in the road and when we
went there to stop them they also started to
assault us with fist and blows and other
sharp tools and somehow my son escaped
from the above group and thereafter they
started to assault me and my husband
continuously without any mercy and my
husband got grievous injury in his
leg and other parts of the body.

was severe hit and they threw my husband
and the about noted people tried to
kill my husband and also threatened me
if I came to save them they will also
kill me and thereafter local people gathered
at that very moment- and seeing such they
left the spot- and ran away and thereafter
I took my husband and my son at
Siliguri Sarda Hospital for treatment and
my husband is gravely injured and
fighting for his life.

It is pertinent to mentioned here that even
today the above noted persons are constantly
threatening my son over telephone that if
I take any legal steps before any authority
they will come at our house and beat them.
and now we are spending our days with
fear.

Therefore finding as other alternative way
we have come before you to take appropriate
legal steps against ① Debjit Saha ② Chetan
③ Bhutta ④ Nobin and his groups for
the interest of justice.
