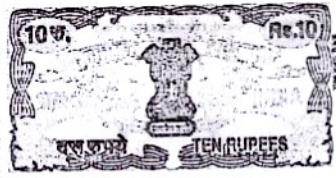

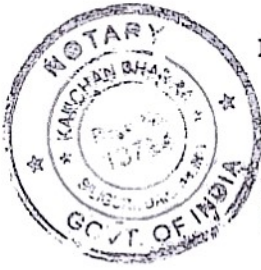

Charge, Cyber Crime Police Station, Siliguri Police Commissionerate against the complainant, his old parents Pawan Kumar Agarwal and Kanta Agarwal and his younger brother Piyush Agarwal and on the basis of the said complaint one case has been started being Matigara Police Station Case No. 65 of 2025 under section 85, 304(2), 115(2) of B.N.S., 2023.

3. That at the time of lodging the said complaint, the complainant was admitted at Neotia Getwell Hospital and the accused person alongwith her mother Nilam Devi Agarwal, her sister Rimpa More, her brother-in-law Dipak More and her brother Bunty Agarwal (Singhal) they all have forcibly entered into the father's place of the complainant at Uttarayan, Matigara and started to abuse them by uttering filthy languages and also assaulted the old father and younger brother of the complainant and for saving their lives they somehow escaped from there and since then they started to stay here and there.

4. That at the time of leaving the house the parents and younger brother of the complainant were compelled to leave all their belongings in the father's residence of the complainant and the accused person and her family members have taken full control in respect of each and every valuable articles/movables and started to enjoy the same most illegally and in unauthorized manner.

5. That since the date of taking the illegal possession of the residence and the valuable belongings of the complainant and his family and its unauthorized occupation and enjoyment, the parents of the complainant have time to time informed the Cyber Police Station in writing for taking the necessary action and the Cyber Police Station have already taken the cognizance upon the complaint of the mother of the complainant.

6. That the accused person has deliberately and intentionally hacked the Google Account of the complainant both personal and business account by using her own mobile device (Samsung Galaxy M31s) being Mobile No. 9749139209 on the following manner:-

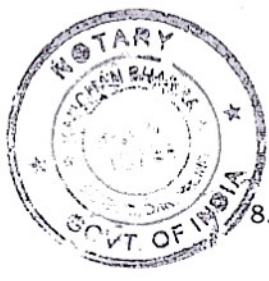

7. That apart from hacking, the accused person along with her above-named family members have also been using the Apple I-Pad (Size: 11 – inch; Colour: Grey; IMEI No. WJ37R543M7) of the Complainant in unauthorized manner and by using the same the accused person hacked the Google business account of the complainant with a clear intention to misuse the personal and valuable business profile and data(s) of the complainant and to put him in a deep trouble.

8. That whenever the complainant got the information/message from Google in his mobile device, he hurriedly took the precaution so that accused person cannot misuse those data(s) but it is very unfortunate that the accused person is very much daring and desperate and she has been frequently hacking the said Google Accounts of the complainant i.e., Personal Mail ID - (ayushreddevil666@gmail.com) and Business Mail ID - (arch2050studios@gmail.com).

9. That on 22.02.2025 the complainant had tried to lodge a written complaint with Inspector-In-charge, Cyber Police Station under Siliguri Police Commissionerate but despite receiving the said complaint the Inspector In-Charge, Cyber Police Station has neither started any specific case against the above-named culprits nor taken any steps for investigating the matter and recovering the afore-mentioned gadgets.

10. That being aggrieved by the same the complainant subsequently lodged a written complaint with the Commissioner of Police, Siliguri Police Commissionerate on 22.02.2025 but till this day no action has been taken by the concerned police authorities.

11. That the present complaint is bona-fide one and for the ends of justice.

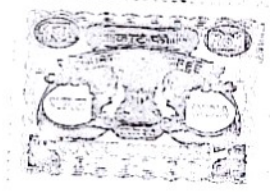
