- I, SI Kalyan Saha of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Biru Ram (30) s/o Gopal Ram of Tinbatti, Alu Gaddi PS New Jalpaiguri Dist.-Jalpaiguri under arrest along with following seized articles;
 - 1 Three(03) sealed Bottles of Himalayan GOLD India Made Liquor, each bottle 600 ml and marked as Ex-"A".
 - 2. Fifteen(15) sealed Bottles of Himalayan Fatafati India Made Liquor, each bottle 300 ml and marked as Ex-"B".

I am submitting a written complaint against the above noted accused person to the effect that today 11.03.25 at 20-55 hrs I received source information that one person was carrying and selling Liquor illegally at Kashnir Colony More under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with SI Tanmay Kundu, C/1462 Sajan Tamang, VP-13 Jamirul Islam, all of NJP PS, SPC left for Kashnir Colony More to verify the veracity of information vide NJP PS GDE No. 580 Dated- 11.03.25. On arrival at the spot on 21.03.25 at 21-15 hrs it was found that one person mentioned above was carrying liquor illegally to his house situated at tinbatti to sell the same his designated customers to earn huge money for his livelihood . On seen the police the above noted person try to flee away, but we apprehended him, on being asked he disclosed his name and address mentioned above and also confessed that he is carrying and selling Id Liquor illegally to his designated customers without any license. Thereafter in presence of witnesses I recovered Three(03) sealed Bottles of Himalayan GOLD India Made Liquor, each bottle 600 ml and Fifteen (15) sealed Bottles of Himalayan Fatafati India Made Liquor from his possession and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor . As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 11.03.25 in between 21-20 hrs to 21-35 (seizure Total approx 6.3 Liters).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Biru Ram (30) s/o Gopal Ram of Tinbatti, Alu Gaddi PS New Jalpaiguri Dist.- Jalpaiguri and arrange for its investigation.
