Brief details of the case

On 12.03.25, a specific information was given by SI(G) BHQ Biliguri regarding the movement of heavy truck carrying cattle heads without valid documents from Dalkhola towards Fulbari. On getting the information a special MCP has been planned and laid at around 120700 hrs by Sh Arvind Pathania, AC, Coy Comdr along with 03 SOs and 04 ORs (including unit 'G' rep) the on NH- 27 near Toll Plaza, Fulbari. At around 120730 hrs the party observed movement of the suspected Truck bearing Reg No UP21CN8226 which was coming from the Mahananda Barrage side. The MCP party stopped the truck bearing No. UP21CN8226. The party asked the driver to produce necessary documents but he failed to produce the proper documents. Accordingly, the party seized 01 heavy truck with 25 no's buffalos, 02 no's buffalos' calves, (Total=27 Nos) and also apprehended 04 Indian nationals with 03 mobile phones (02 Android & 01 keypad) and Indian currency 15,590/-. The buffaloes were badly stuffed inside the truck and were in very terrible condition.

11. In view of the above, you are requested to lodge an FIR against the above persons under Section 11 of the Prevention of Cruelty to Animals Act, 1960 for "treating animal cruelly" & Section 47(a)(b), Section 48, Section 49 (a), Section 50, Section 54(1)(2)(3), of The Transport of Animals rules, 1978 and other relevant sections. Outcome of the case may be intimated to this HQ, accordingly. You are also requested to provide formal receipt of above apprehended person and seizure memo for our record please.

In view of above it requested to kindly lodge an FIR against the above apprehended Indian nationals under sections of cruelty to animal act. Kindly provide the copy of FIR for our record please.
