Respected Sir,

I, Sayra Khatun, wife of Md. Hamid, resident of Digra Bhita, Tarbandha, District-Darjeeling, State of West Bengal, beg to inform you that I run a small Tea Stall near Khanna Hotel, Bagdogra, District- Darjeeling. Yesterday at about 7:00 A.M. when I started to open my shop, suddenly 04 (Four) people namely 1) Zaheena Khatun, Wife of Mafizuddin, 2) Azina Khatun, Daughter of Mafizuddin, 3) Nageena Khatun, Daughter of Mafizuddin and 4) Chotu Bau, Son of Mafizuddin came to my shop and started assaulting me brutally without any reason. Zaheena khatun and Chotu Bau forcefully hold my hair and dragging me out from my shop. Chotu Bau has torn my Saree with intention to publicly humiliate me. They assaulted me with fist and blow severely. At that time my husband namely, Md. Hamid came to my shop and immediately after seeing the incident he came to rescue me but these people started assaulting him also. Chotu Bau hit my husband's head with Bamboo. Azina Khatun and Nageena Khatun Break my shop. At that time they snatched my gold chain which I worn that time which I later noticed.

Now me and my family were very afraid that these people may again came to my house or my tea stall and again assault me or my family.

I therefore request you to kindly take necessary action according to law.
