I, Goutam Sutradhar, residing at Siliguri sevoke road, dasharatpally Ward no. 44, am compelled to bring to your attention a grave and ongoing concern regarding my commercial vehicle, Maruti Suzuki cab, bearing registration number WB-73D-6711 and engine number D13A5164611 and chassis number – MA3FSEB1S00501273.

I'm facing significant distress and financial hardship due to false accusations of pollution and no-parking violations in Kolkata, despite never having driven my vehicle there.
