I, Jhuma Das, D/o - H. Sachin Das, Hindu by religion,
R/o - Community Hall road, 2nd. Jyotinagar Colony, Ward-40,
P.O. Sevoke Road, P.S. Bhaktinagar, Dist: Jalpaiguri, West Bengal
would like to inform you as follows: -

That approx 4 years ago I met with one person namely
Shri. Jayanta Das, S/o - H. Dilip Das, R/o - of the address as
mentioned above. I met with him in the same colony
where I reside.

That after meeting him gradually we have developed a
bond and that has been resulted in conversion of a relationship
and after elapse of few months I came to know about the
fact that he is a druggist and we to do various illegal
activities in perview of his addiction. Later on I started
creating distance with him as he is completely an addict
person.

That after creating distance with him he started abusing
and blackmailing me by stating that he has various personal
photos of mine in his custody on his mobile. He has
on several occasions blackmailed me by threatening me
about such intimate photos and have tried to take undue
advantage of mine. He has physically assaulted me
in middle of the road on several times. I have
managed to escape from his grip every time.

That around 2 months ago I met with one person
namely Shri. Mukesh Chaudhary with whom my
marriage was fixed for the date 01/04/2025.
