REQUEST FOR LODGE FIRST INFORMATION REPORT

Respected Sir,

1. With due respect and humble submission, I would like to inform you regarding a serious incident occurred in the Security Supervisor's Office on 17th Mar 2025 at approximately around 1300 hours. The details of the incident are as follows :-

(a) At around 1250 hours, Security Guard Shivnarayan Singh, S/O Raghunath Singh, Vill- Gurung Basti, PO+PS - Pradhan Nagar, Dist Darjeeling, (WB), Aadhar No 574368036903 & Mob No 9641971460, Subhas Roy, S/O Late Manik Roy, Vill-Durgamata Mandir, PO-Kadamtala, PS-Matigara, Dist-Darjeeling (WB), Pin 734011, Aadhar No 492662825421, Mob No 9547783374, Jogeswar Das, S/O Late Mogin Das, Vill-Pelku Jote, PO-Ranidanga, PS-Matigara, Dist-Darjeeling (WB), Aadhar No 505895921021 and Mob No 9679080872 and few others entered my office in an aggressive manner and demanded to know why they were not permitted to join the new supervisor. I politely informed them that, as a supervisor, I do not have the authority to assign duty to anyone.

(b) In response, Shivnarayan Singh, Subhas Roy and Jogeswar Das started shouting, verbally abusing me and intimidating me with threatening remarks. Shortly thereafter, Shivnarayan Singh physically assaulted me by hitting me, while Subhas Roy and Jogeswar Das assisted him by restraining me and preventing my escape.

(c) The entire incident was captured on the CCTV camera in my office, and I am prepared to share the footage as evidence for further investigation.

(d) Medical Report is also enclosed.

(e) Given their aggressive actions and the manner in which they attacked me, I strongly believe that their intention was to cause serious bodily harm or even endanger my life. I request you to register an FIR against the accused and take immediate action under the relevant provisions.

2. I am an Ex-serviceman, who has honourably served the nation for 34 years, raisin through the ranks from Sepoy to Subedar Major (Honorary Captain). This incident has not only caused me physical harm but has also led to mental distress and a serious threat to my safety.
