In producing herewith three (04) accused persons namely 1)Mukshdul Alom(25) S/o It md sager, Of porajhar, ps Njp Dist jalpaiguri 2)Bikash Darjee (36) S/o Shida Bahadur Darjee, of changmari, PS Nagrakata dist jalpaiguri 3) Rejjak Islam(28) S/o Faridul Islam Of Morbazar, ps Njp Dist jalpaiguri 4) MD Raju (23) S/o It md Jahangir Of jorpakri, ps Njp Dist jalpaiguri along with seized articles viz:-

- One Ram Dao iron made length measuring approx 3 feet with wooden handle and One iron rod, length measuring approx 3 feet which kept in the white colour bag and the bag carries by Md. Raju in his right hand.
- 2. One Nylon rope ,blue in colour length approx 20 feet which carries by Bikram Darjee in his left hand.
 - 3. One baseball strike which carry by Rajjak Inslam in his right hand
- 4.One Electronic torch lights (red colour) which carry by makshedul alam in his right hand.

1 SI Samik Paul of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 10/12 persons to the effect that on the night 23.03-25 at 00-10 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Kishor Sangha ground, Mor bazar under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and noted in NJP PS GDE No. 1108 dt. 23.03.25. As per your kind direction at 00-15 hrs myself along with, C/1462 Sajan Tamang, VP-13 Jamirul Islam VP 08 Laxman Roy left from PS vide NJP PS GDE No. 1109 dt. 23.02.25 for Kishor Sangha ground, Mor bazar to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 00-30 hrs and stopped our vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the ground of Kishor Sangha, found a group of 10/12 persons assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the above noted three (04) persons and the others 08/09 persons managed to flee away from the spot taking the advantage of darkness. On interrogation they disclosed their identity which was not verified and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Kishor Sangha, Morbazar under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not find any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in video graphy as per provision of law. Accordingly I arrested the above noted accused persons u/s 35 BNSS. The seizure was made between 00-40 hrs to 01-10 hrs and the all persons were arrested with proper memo of arrest.



So I pray before you that a specific case may kindly be started against I)Mukshdul Alom(25)S/o It md sager Of porajhar, ps Njp Dist jalpaiguri 2)Bikash Darjee (36) S/o Shida Bahadur Darjee, of changmari, PS Nagrakata dist jalpaiguri 3) Rejjak Islam(28) S/o Faridul Islam Of Morbazar, ps Njp Dist jalpaiguri 4) MD Raju 23) S/o It md Jahangir Of jorpakri, ps Njp Dist jalpaiguri and other 8/9 persons and arranged for its investigation.
