Subject: FIR Regarding Untoward Incident and Threat to Life at Nougahat More.

Respected Sir,

I, Dr. Md. Khalilullah Shiekh, son of Habibullah Shiekh, resident of Quarter No. 165(B), South Colony, Opposite NJP Railway Station, District: Jalpaiguri, West Bengal-734007, would like to file a formal complaint regarding an untoward incident that took place on 12th March, 2025 at Nougahat More, which involved wrongful restraint, threats to my life, assault, snatching and destruction of property.

At approximately 11:42 PM while I was proceeding towards my college campus North Bengal Medical College and Hospital along with one of my junior Sri Joy Kulhari, I saw that a green coloured Hyundai Alcazar Car which was constantly honking at my vehicle and was chasing my car from Nougahat More. The same said car was successful in intercepting my vehicle at Mahananda Bridge near Nougahat More. I was shocked to see that in the said car there was one Sohaib Shahadat who along with three other unknown miscreants unlawfully restrained me and my friend Sri Joy Kulhari. They cornered my vehicle at Mahananda Bridge near Nougahat More and started hurling abusive words at me. I resisted and asked him to stay away from me and my family. On that he started to threaten me that he will implicate me into false and frivolous cases and threatened me with dire consequences to end my life if I did not withdraw the previously instituted case, in which I was the defacto complainant, being Matigara Police Station Case No. 57 of 2025 against Sohaib Shahadat. He also threatened me from disposing my property over whatsapp on which I made specific complaint dated 30.01.2025 to Siliguri Cyber Police Station. The said Sohaib Shahadat suddenly put his hand inside my car and grabbed my collar and asked me to come out of my car. Being frightened by this act of Sohaib Shahadat, I started to close my car window and right on that moment, he grabbed my hand from the steering wheel and snatched my interlock gold bracelet measuring 11.8 grams with such perfection that it was obvious that he had premeditated intention of snatching my bracelet. Thereafter, to protect my life and that of my friend, I somehow managed to close my car window and

started my car and managed to escape the situation. While I was trying to escape, Sohaib Shahadat and his accomplice started slamming and hitting with their hands on my car and started pelting stones at my car which had broken my car rear windshield glass. The Copy of the previous FIR being Matigara Police Station Case No. 57 of 2025 and that of the complaint dated 30.01.2025 made to Cyber Police Station is enclosed herewith for your reference.

Additionally, I would like to bring to your attention that these individuals, including primarily Sohaib Sahadat, had been persistently making attempts to harm my body to an extent of ending my life, hijacking my car and is also attempting to harm my movable and immovable properties. I have strong reason to believe that they are constantly plotting and conspiring to cause further harm to me and my property and to implicate me into false and frivolous cases. Therefore, if the actions of Sohaib Shahadat remain unchecked, I have strong reason to believe that my safety and that of my property is at consistent risk. The said person Sohaib Shahadat is constantly trying to force me to withdraw the criminal complaint that I had previously lodged against him.

I humbly request that an FIR be registered under relevant sections of the Bharatiya Nyaya Sanhita, 2023 including but not limited to wrongful restraint, intentional insult with intent to provoke breach of peace, criminal intimidation, snatching, destruction of property and criminal conspiracy, and a thorough investigation be conducted into this matter to ensure my safety and the protection of my property.

I would appreciate it if immediate action is taken to arrest the accused individuals and prevent any further harm from occurring.

Thank you for your attention to this matter. I trust in your prompt intervention.
