With due respect and humble submission, I SI Manoj Kr. Roy of Matigara P.S do hereby lodge this written complaint to the effect that on 25.03.2025 I was deputed to perform K-33 Mobile Van duty along with force, since 08:00 hrs to 14:00 Hrs vide Matigara P.S. C.C. No. 76/2025, Dated - 25/03/2025 and Matigara P.S. GDE No. 1456/25, Dated - 25/03/2025 in course of said van duty I received source information that 01 (One) vehicle Tractor Blue colour, bearing Regn. No. WB 74 BR 4651 fitted with Trolley is playing at Matigara Bazar under Matigara PS area loaded with river bed materials which was procured clandestinely. On received such information, I force rushed at Matigara Bazari and found the above noted vehicle loaded with river bed materials standing on a road in front of Matigara Bazar. On seeing the Police team the driver of the vehicle managed to flee away from the spot to leaving the vehicle abandoned. It is crystal clear that the driver/owner of the vehicle Tractor green colour bearing Regn. No. WB 74 BR 4651 fitted with Trolley procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to his designated customer for his wrongful gain. I tried hard to trace out the driver Owner of the vehicle but in vain nobody came forward to claim the vehicle.

Finding no other alternatives, I seized the vehicle Tractor Blue colour, bearing Regn. No. WB 74 BR 4651 fitted with Trolley loaded with river bed materials under proper Seizure List under coverage of Videography also brought the seized vehicle at P.S. The whole process of seizure was made in between 12:05 hrs to 12:10 hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver / owner of the seized vehicle Tractor Blue colour bearing Regn. No. WB 74 BR 4651 fitted with Trolley and arrange for its investigation.
