I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do here by lodge this complain empowered by Electricity ACT 2003 (Amendment act 2007) to the effect that Manju Devi Sahani ID: 403254225 KhalaiBaktari ,P.O: Matigara Dist Darjeeling, she has committed use of electricity illegally under section 135 (1) (e) and 138 (1) (b) of Electricity ACT 2003 (Amendment act 2007):

On dated 26.03.2025 at 13.00 hr I along with the accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional office, WBSEDCL, 2) Bijay Lakra, DE & S&LP Darjeeling Regional office, WBSEDCL, 3) Bhusan Lama, 4) Pradip Biswas of Customer care Center Matigara have entered the premise of Manju Devi SahaniS/o Late Baleshwar CON ID: 403254225. During inspection, it has been found that Manju Devi Sahani has extended electricity to the disconnected premises of late Baleshwar Roy (currently used by Ramesh Roy) Con ID: 412128283 having outstanding dues of electricity use. Electricity was disconnected for con ID : 412128283 on dated 05.02.2025. Assessed load of electricity illegally enjoyed by her is 1.17 KVA. The findings are incorporated in the inspection report prepared by me at the site.

As unauthorized use of electricity was detected, arrangement has removed and the connection has been disconnected after preparing a formal seizure list duly signed by the witnesses and copy of the inspection report and seizure list handed over to Manju Devi Sahani.

The inspection team left the said premises at 13.25 hr on date.

Therefore it is requested that a case under section 135 (1) (e) & 138(1) (b) for Manju Devi Sahani consumer ID : 403254225 may please be registered and arrange for its investigation.
