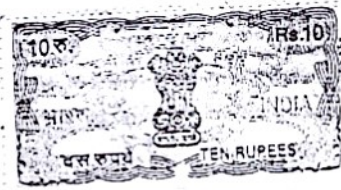

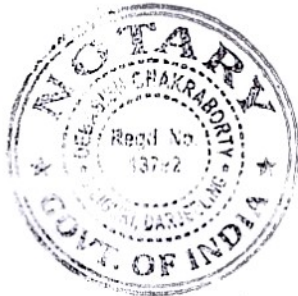

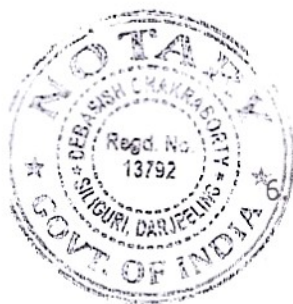
offensive lines towards the complainant such mean that the Complainant involved in illicit activities specially write "Night Video Call available with full face", "Call me: 9832505359", "Call girl is available across here", "Call available 8392060038". All captions are viral in social media platform (facebook) and the caption was posted on the facebook wall in the name of Sandip Ghosh & Madhumita Sarkar which facebook accounts are belongs to the accused persons.

5. That the Complainant started to receive so many phone calls & whatsapp messages from unknown numbers and some abusive and offensive languages and threatens come out from inside the phone.

That on 28-11-2024 the Complainant lodged a written complaint before Cyber Crime P.S., Siliguri against the accused persons but no action has been taken till date.

7. That knowing the fact that accused persons are highlink, police did not start any specific case. After that the complainant lodged a written complaint before the commissioner of police, Siliguri but the commissioner of police did not take any step till date.

8. That the Complainant is the victim of crime committed by accused persons, may be in furtherance of their common intention and the averments of the Complaint clearly makes out offence under Information Technology Act, 2000 and police authorities were required to register the F.I.R. against the accused persons under the relevant sections on the complaint lodged by the Complainant but due to the high links, money power and influence of the accused persons, the police did not take action against the accused persons and only entered the
