Subject: Urgent FIR Registration Against Vishal Manger (Alias "Sikkim Justice Vishal M") for Cyber Defamation of Hon'ble CM Smt. Mamata Banerjee.

Respected Sir,

I. Dr. Suprakash Roy, a law-abiding citizen and a responsible resident of Siliguri, West Bengal, hereby lodge a formal complaint requesting the immediate registration of an FIR against Vishal Manger (alias Sikkim Justice Vishal M) for engaging in cyber defamation and deliberate dissemination of false, Al-generated content with the intent to malign the dignity and reputation of the Hon'ble Chief Minister of West Bengal, Smt. Mamata Banerjee, and former Sikkim Chief Minister Shri Pawan Kumar Chamling.

Details of the accused are as follows:

Full Name: Vishal Manger

Father's Name: Shri Bijay Manger (Retired Sikkim Govt. Employee)

Mother's Name: Smt. Janit Manger

Address: Mainabotay Village, Kamrang Panchayat Unit, Namchi District, South Sikkim, India. Social Media Profile: Operates under the name "Sikkim Justice Vishal M" on Facebook.

The accused has maliciously created and circulated a fabricated Al-generated video portraying Smt. Mamata Baneriee and Shri Pawan Kumar Chamling in an inappropriate and defamatory manner. This falsified content has been widely shared on social media platforms (Facebook, WhatsApp, etc.), leading to

- 1) Severe harm to their reputation as public figures.
- 2) Public outrage and potential incitement of disharmony in West Bengal and Sikkim.
- 3) Misuse of artificial intelligence (AI) and digital platforms to spread fake news.

I, therefore request immediate registration of an FIR under the relevant legal provisions along with the seizure of the accused's digital devices and investigation into his online activities. Besides that collaboration with Sikkim Police (Namchi District) to ensure the arrest of the accused along with the issuance of takedown requests to Facebook, WhatsApp, and other platforms to remove the offensive content. Strict legal action should be taken against him to set a precedent against the misuse of AI and social media for defamation.

As a responsible citizen, I urge you to take swift and strict action to uphold the dignity of our democratic institutions and prevent such cybercrimes from escalating further. Kindly acknowledge my complaint and inform me of further proceedings at the earliest.
