Subject: Complaint against unauthorised occupation of land at Dabgram

Respected Sir,

I, Shri. Keshab Chandra Basak, son of Lt. Haridas Basak, resident of village Jhapushabari, P.O Jhapushabari, P.S Agomoni, District-Dhubri, Assam, Pin-783335, hereby lodge a formal complaint regarding the unauthorised occupation of my land.

It has come to my attention that certain unauthorized individuals have illegally uprooted a peepal tree situated on my land measuring 5 kathas near Satsang Mandir, Bari Bhasa Thakur Nagar, under Mauza-Dabgram, Block-Raiganj, P.S New Jalpaiguri, District-Jalpaiguri, West Bengal. Furthermore, the accused persons have unlawfully removed the fencing of my land (RS Khaitian No.: 651 & RS Dag No.: 258) and are preparing to construct boundary walls using red bricks, which have already been stocked on-site without my consent.

This act of encroachment is illegal and violates my property rights. Therefore, I kindly request you to:

1. Take immediate action against the unauthorized occupants.
2. Stop any ongoing construction on my land.
3. Remove all encroachments and restore my property to its original state.
4. Initiate legal proceedings against the accused individuals under the relevant sections of law.

For your reference, I am attaching the following documents in support of my complaint:

1. Copy of land deed.
2. Mutation Certificate.
3. Land revenue receipt.
4. Geographic Co-ordinaete of the Land: 2604059.2"N 88027'47.3"E

I urge you to investigate this matter urgently and take the necessary legal action to protect my property. Kindly keep me informed of any developments in this regard.
