Respected Sir,

I, Ramashankar Prasad, Son of Hira Mahato, residing at Swami Nagar Colony, Vivekananda Road, also residing at Sattelite Township, Fulbari Gram Panchayat II, Dist- Jalpaiguri would like to draw your sincere attention over the serious allegations and circumstances enumerated herein below :-

1. That I am the owner of a land measuring about 3 kathas of Sattelite Township, resident plot no. 104 at satellite township recorded in Mouza - Binnaguri, J.L. No- 03, sheet no. 11 & 18, P.S.- N.J.P., Dist- Jalpaiguri. And since I became the owner I am continuing my buiseness over my said land.
2. That one Roshni Begum along with her husband Md Salam resident of Chunavati More, are continuously trying to encroach my above stated 3 kathas of land by every hook and crook since January 2025. They even forged by manufacturing false documents in regards to the ownership of the land and trying to take forcible possession of my land by dispossessing me.
3. That furthermore finding no other alternative I was compelled to file a Title Declaration Suit before the Ld. Civil Judge Junior Division at Jalpaiguri vide. Title Suit Case no. 48 of 2025 against Roshni Begaum and Md. Salam. That the Ld. Court was pleased to pass an injunction order vide order dated 21/01/2025 "directing the defendants are restrained from dispossessing the plaintiff from the suit property". Copy of Certified copy of stated order is annexed as "annexure A".

4. That yesterday on 24/03/2025 the said Roshni Begum along with her sister and husband namely Md Salam vehemently tried to enter my land by violating the courts order. Although I filed an complain yesterday afternoon at N.J.P police station in regards to their illegal activities. Eventually the concerned police station did not to any necessary actions resulting to which loosing fear of law the said Roshni Begum along with her sister, husband namely Md Salam and other miscreants and anti-socials namely Md Hafis, Md. Alam with almost 20 other persons attacked my land today at around 11 am with weapons, sharpen knife with a stringent motive to kill me, even they hit me and my son with iron rods just to dispossess me from my land. Taking advantage of being female personals they further even threatened me they will lodge false criminal cases against me and even the concerned police station will not take any actions against the said Roshni Begum, her husband and other miscreants.
5. That immediately in such scenario I dialed 100 to police, and the concerned police went to my land in regards to such illegal activities. That as there were no female police personals they could not restrain them from such illegal activities and finally they left. I and my son in fear of life escaped from my land for meanwhile but when we returned back to my land at evening, I found Roshni Begum, her sister, Md. Salam and their anti-social associates forcefully demolished my gate and boundary wall with JCB bulldozer by vehemently violating the Ld. Courts order of injunction dated 21.03.2025.
6. They even further stole away water pump, generator and working utensils.
7. That every movement of the alleged personals are been recorded in the CCTV footage. A H.P pendrive vide. product code MM-USB064GB-

400P containing all the video footage is annexed herein within the envelope as "Annexure B"

That I humbly pray to the concerned authority to take immediate legal actions against Roshni Begum, Md Salam, Md Hafis, Md. Alam and other persons that how by forging documents and violating courts order, causing damage to my property, stealing my immovable properties, these stated persons even attempting to murder me and my son with an motive to grab and capture my land has executed such illegal acts.
