With due respect, I Smt. Barsha Sarkar@Beuty Sarkar, W/o. Sri Chiranjit Barman, Daughter of Late Ramgopal Sarkar, resident of Netajipally, P.O. Kadamtala, P.S. Matigara, Dt. Darjeeling would like to inform you that I am the legally married wife of Sri Chiranjit Barman and our marriage was solemnized with Sri Chiranjit Barman, S/o. Sri Satish Barman of Mirjanglajote, P.O. New Champta, P.S. Matigara, Dt. Darjeeling on 11.05.2023 at my elder brother house at Ranabusty under Matigara police station performing all ceremony according to hindu law and custom. At the time of our marriage my mother had given Steel Almirah, Freez, TV, dinning table, dressing table, bed with bed materials and 20,00,000 (Twenty lac) cash and gold ornaments worth Rs. 5,00,000/- (Rupees five lac), Soon after the marriage I had started to live with my husband at his father residence at Mirjanglajote, P.O. New Champta, P.S. Matigara, Dt. Darjeeling with my father in law and mother in law namely Sunita Barman and my brother in law Shubha Barman and Dhananjay Barman and their wives and husband's uncle Gopal Barman and his wife they were jointly started torture upon me both physically and mentally. Most of the times under the pressure of intoxication in night time my husband beating me mercilessly. They are not providing meal regularly to me. One day my husband hired his neighbor Smt Milan

Barman and both of them beaten me brutally and I sustained severe injury on my person and I got treatment from Matigara primary health centre.

In this grave situation when their torture was not bearable looking no alternative I have leaved my matrimonial house for save my life and started to live at Netaji pally shibmandir. Since then I am living there.

Therefore, I request you to please investigate the abovesaid incident and take appropriate step according to law from my kind perusal.
