This is to bring to your notice that I, Mr. Swapan Kumar Mukherjee, S/O Late Sudhir Kumar Mukherjee, a Senior citizen of 76 years old & the resident of my own house at 38, Sadhak Ramprasad Sarani ward no: 29 (SMC/Siliguri), along with 2 other buildings of my younger brothers (Mr Tapan Kumar Mukherjee & Mr Falguni Mukherjee) in the same land compound. Of which my youngest brother Mr Falguni Mukherjee had sold 2 portions of the ground floor (of his building) to the below mentioned names in the year of 2013. Out of which one portion of ground floor had been sold to Mr Swapan Patra & the another to Mrs Dipa Bannerjee directly by Mr Falguni Mukherjee. Therafter Mrs Dipa Bannerjee had sold her portion of the ground floor to Mr. Nitai Singha in the year 2024.

Date: - 27.03.2025

That, Mr Nitai Singha before starting to permanently live in his purchased portion of the ground floor had gone for a renovation in the month of January 2025. A labourer working for him during the renovation of his portion badly spat out Gutka on my entrance staircase along with the wall just next to the staircase. Which is a Saliva-soaked mixture of chewing tobacco ejected from his mouth & which is extremely unhygienic and nasty.

Therefore on 06/02/2025at about 11:30 am in the morning I had strongly objected for this unhygienic act by one of the labourer of Mr. Nitai Singha with an urge to remove the same at the earliest, then Mr. Nitai Singha had badly threatened me & threw me off towards the broken debris & concrete of the building materials, due to that I had an injury in my lower back, along with my head & followed by body weakness. Thereby I had to take medicines from a local medical shop to get relief from such extreme pain and fever.

But things got worse as I didn't get an adequate relief from the medicines & thereafter was admitted in Kins Hospital at Siliguri on 15/02/2025 under Dr. Sekhar Chakraborty & team .And was released from the said hospital on 20/02/2025, but could not walk at all neither get up from bed due to Severe weakness. Also to inform you that any injury in my lower portion of the body can be deadly for me as earlier in June 2023 I had gone for a "Total Knee Replacement Surgery" of my leg.

That, the above mentioned person (Mr. Nitai Singha ) also had strangled or Choke the throat of my youngest brother named Mr. FalguniMukherjee by squeezing his neck to have a grip of the same. As Mr Falguni Mukherjee (also a Senior Citizen of 72 years old), a resident in the same land compound, had protested for the brutal & inhuman act of Mr. Nitai Singha.

Under the above mentioned facts, I Mr Swapan Kumar Mukherjee a Senior Citizen of 76 years old, living with my wife who also happens to be a senior citizen, is highly shaken by this type of act of Mr. Nitai Singha. Thereafter, I humbly pray to your kind honour to take an action under your judicious legal hands to pay justice as early as possible. Your expedite action in this regard will be highly appreciated.
