Subject: Lodging of FIR against Mr. Sachin Kumar Singh for criminal intimidation, assault, abuse, defamation, theft, and other criminal acts.

Respected Sir/Madam,

I, Nivedita Singh, wife of Sachin Kumar Singh, daughter of Ashok Kumar Singh, currently residing at Nav Jeevan Apartment, 3<sup>rd</sup> Floor, Block D, Punjabi Para, P.O. Sevoke Road, P.S. Siliguri, Dist. Darjeeling, West Bengal, am filing this complaint against my husband, Mr. Sachin Kumar Singh, son of Shiv Narayan Singh, resident of Naxalbari Station Para, Near Shiv Mandir, P.O. & P.S. Naxalbari, Dist. Darjeeling, West Bengal.

Sir, I humbly state that I have been facing continuous harassment, threats, and physical as well as mental abuse from my husband over the years. Previously, I had lodged a police complaint registered as Siliguri Women P.S. Case No. 106 of 2021, dated 08.08.2021, under Sections 498A/506 of IPC. Furthermore, I have filed a divorce petition under Section 13(1) (ia) of the Hindu Marriage Act, 1955, registered as Matrimonial Suit No. 210 of 2024.

.Despite the cases pending against him and despite both of us residing separately, my husband has continued to threaten and defame me. On today's date, at around 9:00 AM, my husband came to my residence on the pretext of meeting our son, who has been bedridden for the last two years and is under my exclusive care, including medical expenses.

After interacting briefly with our son, he asked to speak with me privately. During the conversation, he suddenly became verbally abusive and began

hurling false, obscene, and defamatory allegations, claiming that I run a sex racket and am engaged in prostitution, even though I am a respectable professional working as an Area Manager with Bajaj Allianz Life Insurance Co. Ltd.

Our daughter, hearing the commotion, entered the room. My husband continued his slanderous rant in front of our children and even told them that they were born out of prostitution. He further threatened to kill me and ruin my life, saying he would drive me out of Siliguri, send me to jail, and make our children homeless.

He stated that he had spent Rs. 2,00,000/- to illegally obtain my call records and also showed my daughter the entire call records of my mobile number.

Since 21st March, he has been harassing my friends, colleagues, and clients, making baseless and vulgar accusations against them as well, including calling one of my female friends and accusing her of being part of my so-called "racket." I have also got calls from my friends, colleagues and clients where they told me that that they were either threatened, verbally abused and accuses, or told that they were a part of the so-called "racket."

When I told him to leave my residence, unable to bear the abuse, he spit on my face and physically assaulted me, hitting me mercilessly, causing a visible bruise on my left cheek and severe pain in my right arm, and pushed me violently against the wall.

He then forcibly took away a bag containing the following valuable items and documents belonging to me and my children:

 My original documents including Passport, Aadhaar, PAN, all school and college certificates, and original sale deeds of my properties in Naxalbari and Bagdogra, including a shop premises in Bagdogra.

- 2. Birth Certificates, Passports, and Aadhaar Cards of both my children, Karcena Singh and Krishna Singh.
- 3. A pouch containing approximately 200 grams of gold ornaments.
- 4. One laptop.
- One iPhone 14.

While he was leaving with the bag, he had picked up a kitchen knife in an attempt to stab me, my daughter immediately intervened and he rushed away.

Sir, I have reason to believe that he is in illegal possession of my call records, and I am seriously concerned about the safety of myself, my children, and my family. I am also suffering humiliation and trauma due to his baseless and vulgar allegations. His actions are criminal, defamatory, and an attempt to destroy my professional career and personal dignity.

Therefore, I request you to kindly treat this as my formal FIR and take immediate and strict legal action against Mr. Sachin Kumar Singh under relevant provisions law, including offences related to cybercrime and illegal surveillance, if applicable.

I am ready to cooperate fully with the investigation and provide any further information or assistance required.
