Most Humble ,I Smt Khusboo mahato, wife of Amit Mahato, Daughter of Sri Nathuni mahato, aged About 22 Years, Resident Of Khalpara, Vivekanand Road, Near Kali mandir, ward no-7 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling, do here by inform you that my younger brother namely Vishal mahato, who is a toto-e-rickshaw driver, today on dated 04/04/2025 around 1 o" clock at afternoon, some dispute create between my brother and another toto driver for carrying passenger in toto-e-rickshaw near railgate suddenly another toto driver namely Md. Rohit started to beaten my brother by iron rod which was kept in his toto and also he attack him with a sharp knife resulting this a cut upon his body due to this blood swelling from his body because a cut on his shoulder, when my brother ran away from Railgate and enter in to our house then suddenly Md.Rohit along with almost 10-15 persons along with some female lady came who are kept bamboo stick and iron rod in their hand and Md.Rohit kept a sharp knife in his hand and they forcefully enter illegally in my house and again start plainting stone on my house and start destroy and break my shop and house they beaten us by bamboo stick and iron rod, some boys kept sharp knife and another sharp weapon like khukri in their hand, they beaten my mother and brother again badly with intention to kill us, some boys grab my mother hair and tore her cloth(Nighty) by badly touching her chest forcefully another persons hit my brother with a iron rod on her shoulder due to this my brother got serious injury and fracture on his shoulder by hitting the rod, again Md. Rohit hit by a sharp knife upon my brother body and my mother got serious injury in her chest and head. They also beat Sonu Paswan friend of my brother who try to save us also he recorded all the incident in his mobile phone, I ran away outside in fear to get help from local people And after looted our house and money around Rs.3,700/-(Three Thousand seven hundred)from counter which is kept inside the shop when the local people came to save us they ran away. In that time my brother gone senseless situation by help of local people I take my brother and mother to Siliguri district hospital for their treatment but where doctor admitted there in hospital because they got grievous injury in their body. The doctor has said that my brother's shoulder is badly injured and fractured because the joint of shoulder was break by hit of iron rod and blood swelling very much from his body by sharp knife attack and now
