- 5. One white color iphone 14+ bearing IMEI No-353981760465850/317713 and containing one jio SIM having no-9470245311

I beg to report that today on 03.04.2025 at 15.55 hrs received source information that three persons are coming to sell illegal procured tablets to their designated customer at back side of Desun Hospital area and may be apprehended with such illegal tablets in that area if responded immediately. Accordingly, the matter was diarized in General Dairy vide NBMC OP GDE no- 91 dated 03.04.2025 and inform the matter to you. I intimated the matter to Drug controller, Siliguri over telephone to present at NBMC OP but due to short time he failed to appear on the spot. Hence, as per your direction without making any delay myself along with ASI Dulal Dey, ASI Prem Bhakta Mallick, C/500 Mayaram Oraon, C/340 Pranab Adhikary left for the spot at back side of Desun Hospital. This refers to NBMC OP GDE No-92, Dated-03.04.2025 and MCC No-688/25, Dated-03.04.2025.

On way I requested two persons namely (1) Bhuneswar Sahani S/O- Late Joginder Sahani (2) Sankar Biswas S/O- Manaranjan Biswas both of Kawakhali Bazar, PO-Sushrutanagar, PS- Matigara, Dist- Darjeeling to stand as witnesses at the time of search and seizure if any and they agreed. I also called one videographer to present at the spot to make videography during search and seizure if any.

At 16.45 hrs we reached to the place at back side of Desun Hospital and contacted with the source, keeping the vehicle at a distance we started watching. Later as pointed by the source we cordoned the area in presence of the witnesses and apprehended three male persons as noted above. We disclosed our identity to them as police personnel. On being asked the persons disclosed their identity as noted above. After disclosing our presence and following all formalities conducted search and recovered a huge quantity of tablets named "Tapentadol Tablets 100 mg Typeek-100" kept in a nylon bag from their joint possession.

On being asked they stated that they were procured the same illegally for its clandestine disposal to their designated customers for their wrongful gain. Further they also could not produce any valid papers in support of such possession of those tablets.

Accordingly, I prepared seizure list and seized the above noted articles, labeled, duly signed by the witnesses and accused persons. Lastly I arrested the accused persons namely (i) Sanjib Mandal (M/50) S/O-Late Ramesh Mandal of Subhashpally, PO-Panjipara, PS-Goalpokhar, Dist-Uttar Dinajpur (ii) Shekhar Kumar Saha (M/40) S/O- Shankar Prasad Saha of Ward no-12, Dharamsala Road, PO+PS+Dist- Kishanganj, State- Bihar and (iii) Asish saha (M/28) S/O- Ashananda Saha of Kawakhali Township, PO- Sushrutanagar, PS- Matigara, Dist-Darjeeling after informing them the ground of arrest. The Seizure was made in between 18.10 hrs to 19.10 hrs.

Under the above, I pray before your kind self to start a specific case against the above noted arrested accused persons namely (i) Sanjib Mandal (M/50) S/O-Late Ramesh Mandal of Subhashpally, PO-Panjipara, PS-Goalpokhar, Dist-Uttar Dinajpur (ii) Shekhar Kumar Saha (M/40) S/O- Shankar Prasad Saha of Ward no-12, Dharamsala Road, PO+PS+Dist-Kishanganj, State- Bihar and (iii) Asish saha (M/28) S/O- Ashananda Saha of Kawakhali Township, PO- Sushrutanagar, PS- Matigara, Dist- Darjeeling under proper section of law and arrange for its investigation.
