I, Kingom Ongma Dinkpa, aged 26 years, d/o Pemba Lame Bhetui, R/O of Salkani, am filing this complaint to bring to your urgent notice regarding the unauthorized and illegal circulation of deepfake pornography content featuring my morphed images on various online platforms.

On 30.03.2025, I was forwarded a pornographic video in which the individual bore a striking resemblance to me. Upon closer inspection, I realized that this was an AI morphed deepfake video where my face had been superimposed onto explicit content. This video had been circulated across various social media platforms including WhatsApp, Reddit & Discord along with my personal pictures.

On Discord, I found a user name ChristWhiper aka Zen - monk, who had been actively posting personal pictures of me and my sister. The morphed video had been posted on 09-01-2025, in the Northeast subgroup of the Discord group ELC VERSION X. The profile remains active and I have recorded the entire post history of the original poster as evidence.

Moreover, I strongly suspect an individual named Sahil Tamang, resident of Panetaroli, Jagapan, Siliguri near DPS, W.B. to be involved.

I request the inclusion of revenge porn provisions, identity theft and other relevant provisions of the applicable laws. It is pertinent to mention that the perpetrator is a former boyfriend of my sister and had previously engaged in similar action against her. Furthermore, I have lodged a formal complaint with the Cyber Crime Dept. vide Acknowledgement No 2320425-0017595, dtd. 30-03-2025.

I, kindly request you to investigate this matter thoroughly and take stringent legal action against the culprits.

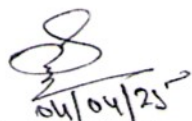

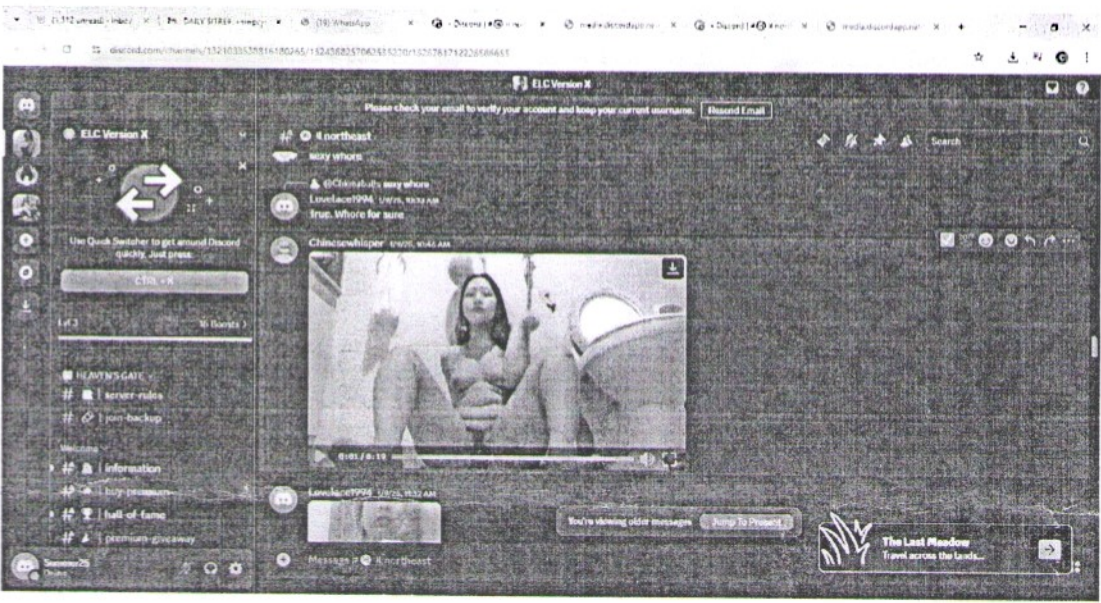
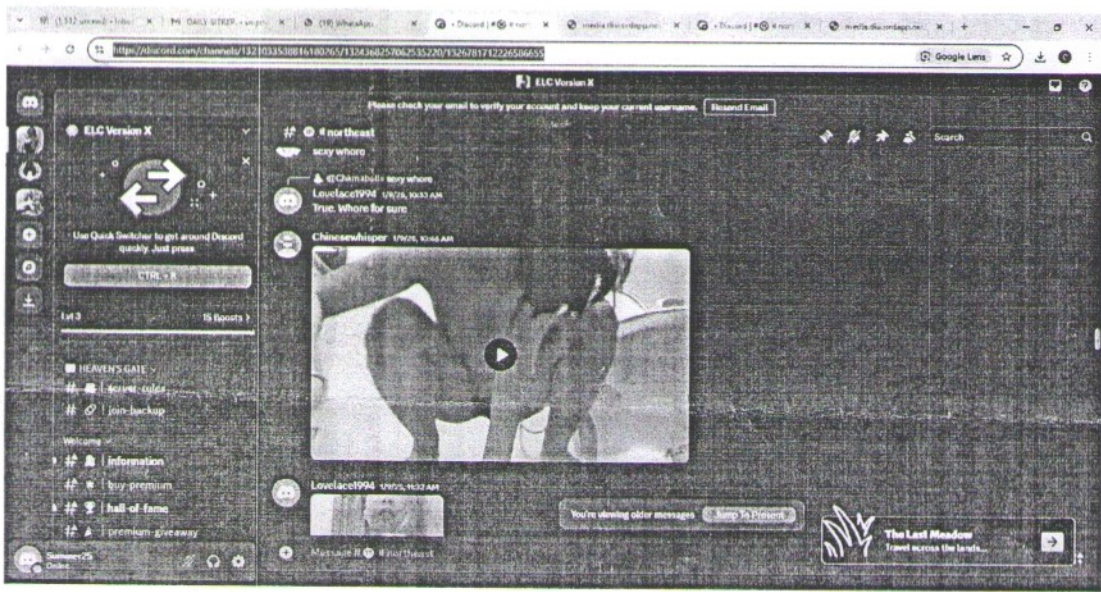
