Respected Sir/Madam

I, Mithlesh Yadav, am the owner of **Samridhi Neuro & ENT Multispeciality Hospital**, located at First Floor, Sikkim Plaza Building, 3rd Mile, Sevoke Road, Siliguri, under Bhakti Nagar Police Station, Post Salugara, District Jalpaiguri.

I am filing this complaint regarding a fraudulent call I received from the phone number 081458 69347 since yesterday. The caller initially introduced himself as Vikram Thapa, an assistant of Bimal Gurung, the President of the Gorkha Janmukti Morcha. He claimed that they were running a campaign against drugs and requested financial assistance.

Later, Vikram Thapa made me speak to another person who pretended to be Bimal Gurung. I have all the call recordings as proof. I became suspicious and decided to verify the matter. Upon speaking with Jitendra Sareen Ji, he directly contacted the Bimal Gurung Ji, and we confirmed that this was a fraud attempt.

The fraudsters provided a bank account under the name **Kitchen Kalimpong** and asked me to transfer money. The account details are as follows:

Since this is a clear case of fraud and impersonation, I kindly request you to take strict action against the culprits. I am also ready to provide the call recordings and any other necessary details for the investigation.
