On 03/04/2025 at around 09:00 PM when I was asking for donation in my local place Accused No.1 with criminal mind Grab my neck very tightly and saying that 'tere karan hum aaj secretary nhi ban paye aaj to hum tere ko maar he denge' Somehow I rescued my self with the help of local person. After sometime at around 10:00 PM Accused No.1 with There men mention above came to my place with the sharp weapon, iron rod, sword and drag me out and Brutally beaten me when my family tried to rescue me, accused No.2 i.e., Minir Sahani attacked to my son with the sword(Talwar) on head neck and stomach for that reason blooding wars continued flow from there and Pradip Sahani fold my daughter's hand and Badly slapped on her check in front of society also there men attacked on my wife they kick and pull dress she wear. Somehow with the help of my neighbour, they take me along with my family in Siliguri District Hospital were we got treated through emergency ward and to see my condition I got admitted emergency ward to male ward also I annexed all medical paper and relevant documents.

aforesaid persons were tried to kill me as being a helpless condition that my wife and my daughter alone living at home were currently living with great fear of death. As taking said advantages the aforesaid persons on several occasions in absence of me tried to outrage

my daughter and wife's modesty and I presumed that the aforesaid persons will again attack me with the intention to kill me as they said earlier on the day of the incident.

Therefore being a helpless I am requesting you to take proper legal action against them as per the procedure of law and look into the matter.
