Lakhman Sahani, resident of Maharaj Colony, Siliguri, would like to inform you that on 03-04-2025 at about 9 P.M. a Pujā / religious gathering took place near my home and at that Pujā / religious gathering some people by the name, Sri. Lakshman Sahani S/o Lt. Jogender Sahani and Sri. Abhishek Sahani S/o Sri. Lakshman Sahani, being drunk, started creating a ruckus and when I went there to give my objections to such hooliganism and unlawful act and conduct of them. They started to misbehave with me and physically abused and attacked me and my son, Master. Abhinav Sahani (Age - 15 years old). We both were badly beaten

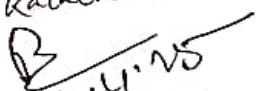
with bamboo sticks and steel rods. I and my son were badly hurt, bleeding and were immediately taken to Siliguri Hospital by my rest of the family members. 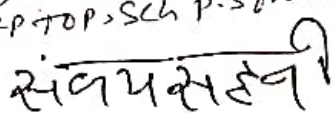
