I, Hritika Debnath [24 years], D/O - Biplab Debnath, residing at Rabindra Nagar More, Rathkhola [near "Maa Annapurna Vandar"], Ward No. 22 of Siliguri Municipal Corporation, P.O. & P.S. - Siliguri, District -Darjeeling, Pin Code - 734006; beg most respectfully submits that one Ayan Das, the details of the accused is given herein below, is my colleague and both we are employee of a Company, name & Style "Decathlon Sports Acropolis Kasba Connect". Prior to engage as employee of the said Company, we have got intimated with each other on and from the year' 2020. Thereafter we have developed a better intimacy relation in the year' 2021 and since 2021 said Ayan Das assured me that he will marry me and since then we have passed our relation as like as husband and wife. In spite, I am senior to said Ayan Das with respect to our job but he is elder than me. On being assured from said Ayan Das and he behaved and all the gesture and posture always revealed to me as we are married couple and on such assurance found to be genuine, I started to believe him as my husband and we both passed our days since the year' 2021 as husband and wife. Said accused [Ayan Das] has taken me in different place in different Hotel, where we are stay in a single room as husband and wife where making me absolute believe to be husband, said Ayan Das cohabited me without my consent as I am not agree with such relation prior to our marriage. But said Ayan with a criminal mentality believe to be husband, he induced me to cohabit with him.

That apart, taking such believe and also availing the advantage of my innocence, whereas I absolutely believed Ayan as my husband, I have compelled to give him financial assistance time to time due to his financial inadequacy. Said Ayan Das by way of adopting fraudulent tactics dishonestly

forced me to avail loan from financial institution for his benefit and upon his assurance for payment of loan amount, I have taken loan of Rs. 8,23,000/-[eight lakhs twenty three thousand] from Axis Bank and I have transferred Rs. 8,00,000/- in his Account for his business need. As soon as the amount has transferred in his Bank account in the last part of the year' 2024, said Ayan Das started to avoid me and he ultimately stopped all the relations and connection with me without any reason. The above named Ayan Das taking advantage of my believe and assurance, he forcefully cohabited with me and also fraudulently with deceiving mentality believed to be husband, induced me to give/transfer Rs. 8,00,000/- in his bank account. Apart from taking away the Rs. 8,00,000/- from me said Ayan prior to that on many occasion he manipulated me, with emotional force, to extend him financial help which resulted I have to pay almost Rs. 1,20,000/- phase by phase. Said Ayan has closed all the communication with me and he did not attend my phone call as well as never respond with repay the loan amount which ultimately put burden upon me.

Considering the above facts and circumstances, as stated above, you are humbly requested take appropriate legal action against Ayan Das immediately so he could not able to evade from legal consequences.
