
I, Smt. Munni Devi, W/O- Khem Chand Agarwal, R/o Ashrampara, Saradamoni road, Opp. Ramkrishna Math, Within Siliguri Municipal Corporation, Dist. Darjeeling, being a senior citizen, aged about 80 years old, beg to draw attention of your concerned authority that my daughter in law Smt. Uma Kumari Agarwal, W/o Naresh Kumar Agarwal, D/o Mahabir Agarwal, R/o Ashrampara, Saradamoni road, Opp. Ramkrishna Math, Within Siliguri Municipal Corporation, Dist. Darjeeling, is inflicting continuous hurt, torture to me, my husband and my son Sri Naresh Kr Agarwal and my only minor grand son. I made my son married to Smt. Uma Kumari Agarwal who is divorced previously on the hope that after the death of my 1st daughter in law, she (Uma Kumari Agarwal) will be a good mother of my grand son and will take care of my us as and my middle son (2nd of 3) Sri Naresh Kr Agarwal who is the only earning member of my family. Me and my husband are senior citizens, knowing that my daughter in law never showed any respect to us nor any helping hand to our daily household courses. There were instances that she kept sleeping until noon and when i asked her for my medicines she physically abused me by '**khud ka kam khud kar lo**'. Smt. Uma Kumar Agarwal made it a habit to instigate me and my husband over petty issues and never pay attention to her minor step son. My daughter in law usually refrain from supporting my family by any means and mostly stays out of home spending my son's hard earned money irresponsibly or keeps sleeping all day long and ordering me and my aged husband to act as a slave for her. One day she slapped me, because i didn't respond to her orders saying '**buriya tu koi kam ki nahin hai**' and threw all my medicines into the dustbin. Another day she got into a quarrel with her father in law namely Khem Chand Agarwal s/o Late Jhabar Mal Agarwal, by throwing his dinner plate outside the window stating '**khane ke liye kamana padta hai**' and pushing him at the door corridor and my husband got injured. After the incident my daughter in law threatened my husband by saying that if he goes to visit the doctor with my son with respect to this incident, there will be serious consequences. These are the instances where my family is getting threatened each and every day and sometimes hurt, insulted, abused and sometimes even worried to tell my son as he is in his workplace and it will disrupt his (son's) life. Such cruelty is not only a part of their life but whenever my son come home from work she started yelling at him without any rhyme and reason skating that '**main tumha re bacche (my minor grand son) ko nahi sambhal sakti yah Meri jimmedari nahi Hai**' and throws knife scissors to injure my son and one night after hearing some noise from my son's room, I went there and pushed the door of the room and found that she was beating him with fists

and he shocked enough to wake up. Seeing these incidents, I informed my daughter in law's mother namely Smt. Bhagwati Devi, w/o Mahabir Agarwal and brother Purushotam Agarwal s/o Mahabir Agarwal, residing at Bakali, Maynaguri, about all the harming activities that Smt. Uma Kumari Agarwal is continuously doing. Yet they supported these dangerous activities and ignited her to continue with this behaviour which came as a big shock to me. Me, my husband with my son kept silent so that our family relation somehow recovered but after a lot of efforts from me and my family including my son and my minor grand son to adjust with Smt. Uma Kumari Agarwal proved as failed. Smt. Uma Kumari Agarwal obviously failed to accept my minor grand son as her Step-son after prolonged and hearty efforts from my whole family and still with these continuous effort she is keeping on misbehaving as the inhumanity aggravated to such an extent that my daughter in law after beating her step-son namely Master Kaushal Agarwal s/o Naresh Kumar Agarwal age 14yrs. old, mercilessly because she never accepted him mentally as her own mother even threatened us to kill if we tried to stop her from beating my minor grand son. It is pertinent that I still tried my best to retrieve the situation created day in day out but my eyes were wide open when I came to know about the incident that my daughter in law attempted to kill her sleeping step-son by suffocating him with a pillow on his face to stop breathing on 5/4/2025 at morning 9 o'clock(a.m.) and at that very moment I was passing by the room and after hearing the death rattle out of suffocation rushed to save my grandson and immediately called my son and took him to Doctor.

After all these daring incidents I with my whole family is in a fear of life threat to me and my family.

It became a dire necessity to inform your concerned authority about such an alarming matter and I took no longer so that you will emergently take necessary action against my daughter in law Smt. Uma Kumari Agarwal so that she cannot commit such grave crime and safeguard our family from such cruelty.
