Puja occasionally or going on to ~~nearby~~ nearby my house and there some boys were using slang and foul language in front of some senior men & women of our colony and when I said to not use this type of language then he went to their place but suddenly after some time near about @ 10:15 PM gang of 20 to 40 people came to my home in absent of mine ~~randomly~~ ^{randomly} attacked to my wife, Puja Deb, my father Rajesh Chandra Deb, and my neighbour brother Sanjay Gupta, and Sister Rupa Sikdar mainly to them and whatever came between to the smaller they have beaten all with rod, stick and with some ~~to~~ larger weapon like knife or blade and they all mainly broke my gate and enter to my home and very badly they have given kick to all my family member and after that when I came mainly I saw person name, Sohil, Ashish, Gourav, Chota Banta (nick name), Reja, Prem Pouth, and ~~other~~ others, and when I came to stopped them they all hit me with blade, and metal scald, and also hit my wife and scratch her neck and try to hit physically in but every body parts after that I and all the victim went to civil hospital Siliguri and reported to the present doctor and same doctor has advised that they have physically assault to my sister by kicking ^{not} ~~had~~ done to my wife same paper of doctor prescribed I am attaching.
