Dey Road, Siliguri, hereby wish to formally report an incident of theft involving my mobile phone.

On April 11, 2025, at approximately 8:17 AM while returning home from Siliguri Junction, I discovered that my Samsung S24 Ultra was missing. I am convinced that my phone was stolen, as I did not misplace it; it vanished in the busy surroundings of the station. Initially, I have been unable to identify the perpetrators or any reliable witness during this occurrence, but the sudden disappearance and the commotion in the vicinity strongly indicate an act of deliberate theft.
