Sir,

With due respect I, SI Kalachand Mandal presently posted at Khalpara Town Outpost under Siliguri PS under your kind control do hereby lodge this written complaint against 200/250 unknown unruly mob of two different groups to the effect that today date: 14.04.2025 at around 05.05 hrs myself received an information that two groups of people both male and female assembled unlawfully and came face to face and promoting enmity between them by raising slogans and counter slogans and also carrying bamboo, sticks, iron-rods at Jyotinagar near Charak Math, Ward No. 04 under PS. Siliguri. Accordingly I diarized the fact vide Siliguri PS GDE No. 586 Date: 14.04.2025 and information the matter to I/C Siliguri PS and ACP, East – I, Biswajit Ghosh (Night CS-1 Patrolling officer with force), ASI. Pabitra Das (Night K-22 Patrolling officer with force), ASI. Debesh Mondal (Night K-21 Patrolling officer with force) for Jyotinagar near Charak Math, Ward No. 04 under PS. Siliguri vide GDE No. 587 Date: 14.04.2025. On way to Jyotinagar I also contact SI. Sudip Dutta O/C Khalpara TOP under Siliguri PS over the matter and conveyed him that he has been directed to come to the spot by the superiors.

At around 05.35 hrs we appeared at the Jyotinagar near Charak Math , Ward No. 04 under PS. Siliguri and found a gathering of approx 200/250 unknowns both male and female divided in two groups appeared face to face and showing & promoting enmity between them by raising slogans and counter slogans and also the carrying bamboo, sticks, iron-rods with them, the two groups raising slogans on grounds of religion. Immediately I along with force intervenes the situation and firstly addressed them that they have no valid permission and they assembled at the ground unlawfully. Both the members of two groups did not pay any heed to the word of the Police and continuing there unlawful activities. Seeing the situation I also direct them to keep aside the bamboo, sticks, iron-rods they are carrying with them and to stop addressing provocative slogans but in vain. In-presence of Police some members of each groups became more furious and engaged in a hot altercation and became unruly and started beating each other with the bamboo, sticks, iron-rods, accordingly we tried to restrain them but the members both of the groups intentionally obstructing Police in the performance of their duties who are engaged in maintaining public order and attacked Police personnel on duty. Finding no other option we started dispersing the members of the two groups.

In between this the members of the two groups went to the opposite of the Charak Math and started pelting stones to the Police personals intentionally harming a public servant while they are performing their duties and to deter the public servant from doing their job, due to the stone pelting SI. Biswajit Ghosh (Night CS-1 Patrolling officer with force), ASI Pabitra Das (Night K-22 Patrolling officer with force), ASI, Debesh Mondal (Night K-21 Patrolling officer with force) sustained injury on themselves. Thereafter we started chasing the unruly mob and they began to flee through the local alleys, while we went to the alley and found that while escaping the unruly mob vandalized several e-rickshaws and vehicles parked in the local alley and also it learnt that the unruly mob of the two groups had threatened the local people in various ways on the way to escape and also seriously injured several people standing on the roads. This act of those unruly mob divided in two different groups create an atmosphere of fear in the locality. The act done by the unruly mob hamper the public order and created a tensed situation over the area. Finally at 09.05 hrs we took control of the situation by patrolling over the area.

After this myself returned to PS and filing this written complainant against the aforesaid persons 200/250 unknown unruly mob for gathering at the field without and valid permission unlawfully carrying bamboo, sticks, iron-rods, to raised slogans and counter slogans on grounds of religion with an intention to break peace of the area, to restrain and attack on duty Police personnel with an intention to deter them maintaining law and order pelting stone on Police, to vandalizing the Public property, assault the public violating the Public Order in general and register the FIR under proper section of law and to arrange proper investigation of this FIR.
