Sub: Application for written Complaint /FIR

I Savita Agrawal married to Pankaj Agrawal, Resident of B-2, Mahalaxr Garden, Near Mittal Gardens, on 16-4-2016, Bhakti nagar Police Station, war No- 41 as Per Hindus Customs & traditions. I am currently residing at Nathula Par Apartment, Ward No-13, Siliguri Parnami Mandir Road, Siliguri Dist-Darjeeling.

1. At the time of my marriage my parents spent good amount beyond the capacity approximately (14 Lakh) fourteen Lakhs in my marriage. But my husband father-in -law Pawan Agarwal, mother in law Pushpa Agarwal shown the disagreements & were not pleased with marriage arrangements gifts & gold given by my parents.
2. Soon they Started asking for 6 (six) Lakhs of amount in cash they starte taunting & misbehaving me & teasing me for not coming with demanded down. My father begged them & convinced them to fulfill their desire for my happy married life.
3. This was my & my husband second marriage, and in his first marriage, husband and my in -laws were in Jail due to dowry, harassment & domestic violence to the first wife.
4. My mother in law Puspa Agarwal, Father in Law Pawan Agarwal, Sister in law Poonam Agarwal started conspirating against me to remove me from the house, marry my husband to a rich girl. They all harassing & torturing me, threaten me for not fulfilling their demands. In August 2017, my husband called my brother and sent me my parent's home forcefully & asked me to come back when I see parents fulfill their demand.
5. No one contacted me for two and half months and in Oct 2017 my husband came to dissolve this marriage because my parents could not fulfill my in law demand. My father and I begged for social reputation and he took me back.
6. On 3rd Nov 2017 my husband went to meet a girl in diburgardh Assam nam Priyanka Agarwal. I came to know about this in my only brother marriage and was attending the whole marriage like a dead body and could not enjoy a single

bit. He broke my trust but I had no option but to continue this marriage because of my second marriage. My Mother in law used to say "DO TAKE KI GHATIYA S LADKI, ISKA MAIN HISAB KITAB BARABAR KARUNGI. ISSE ACHE SE BADLA LUNGI"

7. As I was not fulfilling their demand on 3rd Jan 2018 my husband Punched me So badly that I got swollen and extreme pain in my jaw line, My felt buzzing sound in my ears. He forcefully pushed my head against the wall & threatens me that I am intentionally doing all these so that you can break this marriage by filling a complaint so I can marry that prity rich girl

8. In the morning I had such severe pain I couldn't even chew a banana I was not any treatment. My father in-law asked my father to come & get me treated. Every now & then visiting to my parents house and using abusing & filthy Languages was my husband & mother in-law common nature. The same, he did key visiting on 5th January 2018 before my newly wedded Sister in law & mother's Sister, Kanta Agarwal. He was abusing for not fulfilling their demand. My brother-in-Law (Rakesh Agrawal) & maternal Uncle. (Manoj Agarwal) along with my father took me back & father-in-Law strictly told to my parents take me back, because they have decided to marry their son with that prity rich girl

9. In July 2020 he took me outside showing me different houses to settle outside and asking me to tell my father to do his setting. ^{too early (Call in her room)} ~~switched~~ my phone and tell me I will not left your life normal. He Left me again at my parents home to my. My brother took me there to save our reputation.

10. My husband threw Slippers, hat water from Cattle, cold water from glass all over me. I Screamed badly & visited Drs. alone when I used to sick. He used to me & I wish Tumhara Accident Ho Jaye, Aur Tum Mar Jao". Twice I opened the train's door to commit suicide. My husband and my mother in law used to sleep together to tortured me more and more while I objected it multiple times.

11. He used to take me outside. I while in Car he slapped me multiple times & screamed at one that to show his family & Society I have to do this. I had more gifts from my brother's family than your family. . The torture did not stop here, my husband use to keep my phone closed in his drawer for long time, once he kept my phone" 3 weeks his locker. I used to beg phones from maid and could call my parents.

12. Panic attracts, Jerks while sleeping, did not stop here my father in law and mother in law on 31-08-20 to misbehave and threw plate on my mouth. When my

while serving breakfast. I called my parents if they don't take me from here I will see me dead. Then my brother came and I filed complaint with the Malayaog. But No results came out of this. My husband filed a divorce Case against me but I reconciled with him, due to save my second marriage.

13. He then took me back on 6th January 2022. But within 10 days he started again torturing me with no limits. Chasing random girl in the name of friendship twisting my wrist badly and blood came from my hand because of my glass bangle. These kind of tortures continue as he started messaging those random girls having multiple extra marital affairs.

14. He then bought a new home in Rishikesh in August 2023 and I started living there. In 25th November 23 he pushed my head against wall and on the floor. But I kept myself mum by thinking he will change his behavior at new place. On 1 April 2024 he slapped me so many times I got cuts on my face and injured badly that I had to get me treated in AIIMS Rishikesh.

15. I was so weak I didn't even go to police station. On 20th and 23rd April I husband again abused my parents me and threaten me so much that to Save my life I have to call police on 112, and, I had to lock myself in the bathroom. Police came & save me & Scolded my husband, mother in law. Even My sister-in-law Poonam agarwal was supporting my husband.

16. When Police went they threw my entire Luggage outside the house, to away my ornaments from me. Helplessly had to take refuge to Hotel "Govt Palace in Rishikesh, where he came in the morning & I had to call 1090 to get help. Somehow I reached to my Parents home at Siliguri on 26th April 2024 and staying here since then with them.

17. In between my husband messaged me that he will dissolve this marriage even though I didn't file the Complaint because. I was completely depressed & sick also thought he could Change his behavior. On 22nd February 2025, my husband asked me to dissolve this marriage by taking some amount & threaten me to go to Court. He used very filthy & harsh tone.

18. Recently they are asking through multiple people in the month of March 2025 to dissolve this marriage & Pressurize us & threatens If we don't they will share us. Once My Father in Law met me on the way and threatens me to do as per their desires. I couldn't say anything and came back to home.

All the torture has extended to every Pillar of my life now my tolerance has crossed all limits. Therefore in these situations, I came before you & filling the Complaint & Prays for taking necessary legal action against the above named Person for Such type of heinous crime of physical as well as mental torture & threatening situations.
