Subject: - F.I.R.

Sir,

With due respect, I am producing herewith the following seized articles viz :- (i) One paper made cartoon containing 11 (eleven) bottles of "Budweiser" Magnum Beer containing each bottle 650 ml i.e. total (11X650 = 7.150 Ltrs) marked as Exhibit-A, out of which 01 bottle of the same taken as sample for examination marked as "Exhibit-A1" and (ii) One paper made cartoon containing 12 (Twelve) bottles of "TUBORG" premium Beer each bottles containing 650 ml. total (12X650 = 7.800 Ltrs) marked as Exhibit-B" out of which 01 bottle of the same taken as sample for Examination marked as "Exhibit-B 1". I ASI Biplab Kr. Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against accused namely Sachin Roy @Nangra S/o Lt. Ram Sagar Roy of Rajendra Nagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 16.04.2025 at 01.05 hrs I received source information that one Sachin Roy @ Nangra of Rajendra Nagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is selling illicit liquor illegally at his residence and he stored huge quantity of illicit liquor at his residence without any valid documents. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No. 792 dated 16.04.25 and informed the matter to you. As per your kind order and direction, I along with SI Goutam Mallick, SI Rajiv Subba, SI Bandhan Roy, C/1411 Ashok Roy C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Rajendra Nagar Coolopara under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. On arriving at the spot and contacting my source. Then as identified by the source, I along with other officers and force conducted a raid at the residence of said accused Sachin Roy @ Nangra of Rajendra Nagar, Cooliepara, Ward No-01 under PS- Pradhan Nagar, Dist. - Darjeeling in presence independent witness but found he is absconding. On search in presence of independent witnesses, the above-mentioned illicit liquor was recovered from his residence which he kept concealed inside the bedroom of his residence. We searched every possible place to find the accused Sachin Roy @ Nangra but found absconding. During enquiry it could be learnt that the said Sachin Roy @Nangra S/o Lt. Ram Sagar Roy of Rajendra Nagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling is running such type of illegal business of selling illicit liquor at his residence without any valid documents for his wrongful gain. As the said Sachin Roy @Nangra S/o Lt. Ram Sagar Roy of Rajendra Nagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling violated the norms of Bengal Excise Act, hence I seized the above noted illicit liquor under proper seizure list in presence of witnesses and brought to the PS for further investigation. The whole process of search and seizure was made under the coverage of video graphs in between 01.55 hrs. to 02.15 hrs. at the spot as per norms of BNSS.

Therefore, I pray before your good self that a specific case may kindly be initiated against accused namely Sachin Roy @Nangra S/o Lt. Ram Sagar Roy of Rajendra Nagar, Cooliepara, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
