The Details of the incident is as such;

My father Mr Madan Mohan Choudhury happen to
be a medical patient having a heart condition. (2)
While we were on our way to hospital for his
medical condition checkup we encountered a
two wheeler parked in the middle of the road,
completely blocking our way. We politely
requested the individual standing to remove the
vehicle so that we could pass. However, instead
of cooperating, they refused and started arguing
with us. They repeatedly gave slangs to
me and my brother (Mr. Sujit Choudhury).
